AMENDED AND RESTATED BY-LAWS
OF
AMERICAN FRIENDS OF THE
NATIONAL PORTRAIT GALLERY (LONDON) FOUNDATION, INC.

Adopted March 3, 2015

ARTICLE I.

OFFICES

SECTION 1. Principal Office. The principal office of American Friends of the National Portrait Gallery (London) Foundation, Inc. (the "Foundation") in the State of Delaware shall be in the City of Wilmington, County of New Castle. The name of the resident agent in charge thereof is Corporation Trust Company.

SECTION 2. Other Offices. The Foundation may have an office or offices at such other place or places, either within or without the State of Delaware, as the Foundation's Board of Trustees (the "Board") may from time to time determine. The Foundation may keep the books and records of the Foundation at such place or places within or without the State of Delaware as the Board may from time to time designate.

ARTICLE II.

MEMBERS

Effective as of September 11, 2014, each person who is or previously was a member of the Foundation is deceased or has either resigned his or her membership or has not been at all involved in the activities or operations of the Foundation for ten (10) years or more. Accordingly, unless and until otherwise determined by the Board, the members of the Foundation shall be those persons who are serving as members of the Board, but only while such persons are serving as members of the Board.

ARTICLE III.

BOARD OF TRUSTEES

SECTION 1. Powers. The business, property and affairs of the Foundation shall be managed by the Board, and except as the officers of the Foundation are specifically authorized pursuant to the provisions of Article IV hereof, the disbursement of the Foundation's funds and the disposition of its property in fulfillment of its corporate purposes shall be vested in, and controlled by, the Board. The Board members shall act only as a board, and the individual Board members, acting solely in their capacities as Board members, shall have no power to act on behalf of the Foundation. This limitation on the power of Board members to act in their individual capacities on behalf of the Foundation shall not limit the power or authority of such individuals to act on behalf of the Foundation in their individual capacities as officers of the Foundation as prescribed in Article IV hereof. In furtherance and not in limitation of the foregoing and the powers conferred by the Certificate of Incorporation of the Foundation, the Board, in fulfillment of the corporate purposes of the Foundation, is authorized and empowered, in its absolute discretion, to seek to acquire by gift, bequest, devise, contribution, purchase or otherwise money and property of any kind, nature and description, real or personal, tangible or intangible, wherever located, without limitation as to amount or value, and to make grants and contributions and otherwise render financial assistance to any organization organized and operated exclusively for scientific, charitable, literary or educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, whether within or without the United States. Any reference in these By-Laws to a section of the Internal Revenue Code shall be deemed to refer to the provision of that section of the Internal Revenue Code of 1986 as in effect on the date hereof or the corresponding provision of any subsequent federal tax law.

SECTION 2. Committees. The Board may designate one or more committees, each committee to consist of two or more Board members. The Board may designate one or more of its members as alternate members of any committee, who may replace any absent or disqualified member at any meeting of the committee. In the absence or disqualification of a member of a committee, the member or members thereof present at any meeting and not disqualified from voting, whether or not he or they constitute a quorum, may unanimously appoint another Board member to act at the meeting in the place of any such absent or disqualified committee member. Except as otherwise provided by Section 141(c) of the General Corporation Law of the State of Delaware, any such committee, to the extent provided in the resolution of the Board, shall have and may exercise all powers and authority of the Board in the management of the business and affairs of the Foundation.

SECTION 3. Number, Classification, Election and Term of Office.

(a) The number of Board members shall be not less than three (3) and not more than thirty (30), as specified by resolution adopted by the Board at any meeting thereof called, at least in part, for such purpose. Any vacancy on the Board resulting from an increase in the number of Board members shall be filled in the manner set forth in Section 7 of this Article III. Any decrease in the number of Board members shall not, by itself, shorten the term of any incumbent Board member.

(b) With effect from and after the March 2015 annual meeting of the Board, Board members shall be divided into three classes, designated Class I, Class II and Class III, and at such meeting of the Board, the Board shall assign each of the Board members then in office to one of such classes. Each class shall consist, as nearly as possible, of one-third of the total number of Board members constituting the entire Board. Initially, Class I Board members

shall serve until the 2016 annual meeting of the Board, Class II Board members shall serve until the 2017 annual meeting of the Board and Class III Board members shall serve until the 2018 annual meeting of the Board. At each annual meeting of the Board beginning in 2016, successors to the class of Board members whose term expires at that annual meeting shall be elected for a three-year term. Each Board member so elected shall hold office until the next election of the class in which such Board member is included and until his or her successor shall be elected or, if earlier, his or her death, resignation or removal in the manner hereinafter provided. If the number of Board members is changed, any increase or decrease shall be apportioned among the classes so as to maintain the number of Board members in each class as nearly equal as possible.

(c) Except as otherwise provided in these By-Laws, each Board member shall be elected by a majority vote (which need not be by ballot) taken at any regular or special meeting of the Board members then in office, including, for this purpose, any Board members then in office who are standing for reelection, .

SECTION 4. Organization. Each meeting of the Board shall be presided over by the President of the Foundation or, in his or her absence, a chairman chosen by a majority of the Board members present at such meeting. The Secretary of the Foundation, if present, shall act as secretary of the meeting, or, if he or she shall not be present, a secretary appointed by the chairman of the meeting.

SECTION 5. Resignation. Any Board member may resign at any time by giving written notice to the Board or to the President and Secretary of the Foundation. Such resignation shall take effect at the time specified in such notice, and the acceptance of such resignation shall not be necessary to make it effective.

SECTION 6. Removal. Any Board member may be removed at any time, with or without cause, by a majority vote (which need not be by ballot) taken at any regular or special meeting of the Board members then in office (including, for this purpose, the Board member subject to removal). Notice of the proposal to remove such Board member shall be included in the notice of such meeting. The vacancy in the Board caused by such removal may be filled by the Board at such meeting in the manner set forth in Section 7 of this Article III

SECTION 7. Vacancies. Any vacancy in the Board (whether because of death, resignation, removal, an increase in the number of Board members or any other reason) may be filled by a majority vote (which need not be by ballot) of the Board members then in office taken at any regular or special meeting of the Board. Notice of the proposal to fill any such vacancy shall be included in the notice of such meeting. Any Board member elected to fill a vacancy in any class of Board member shall hold office until the next election of the class for which such Board member shall have been elected or, if earlier, his or her death, resignation or removal in the manner hereinabove provided.

SECTION 8. Meetings.

(a) The annual meeting of the Board for the election of Board members and for the transaction of such other business as may come before the meeting shall be held on the first Tuesday in March of each year at a time and place to be specified in a notice of the meeting furnished to Board members in accordance with Section 8(d) of this Article III. If the election of Board members shall not be held on the day designated for any annual meeting, or at any adjournment thereof, the Board shall cause the election to be held at a special meeting of the Board as soon thereafter as may be convenient. At such meeting, the Board may elect the Board members

and transact other business with the same force and effect as at an annual meeting duly called and held.

(b) Regular meetings of the Board may be held at such times as the Board shall by resolution determine from time to time. If any day fixed for a regular meeting shall be a legal holiday at the place where the meeting is to be held, then the meeting shall be held at the same hour and place on the next succeeding business day not a legal holiday. Notice of regular meetings shall be given to Board members in accordance with Section 8(d) of this Article III.

(c) Special meetings of the Board shall be held whenever called by the President or by any three (3) Board members other than the President. Notice of the time and place of each such meeting shall be given to each Board member in accordance with Section 8(d) of this Article III.

(d) Each Board member shall furnish to the Secretary of the Foundation a post-office or e-mail address or fax number at which notices of meetings and other Foundation notices may be sent to him or her. Except as otherwise provided by law, notice of the time and place of any meeting of the Board shall be given to each Board member, not less than ten (10) days nor more than sixty (60) days before the day on which the meeting is to be held, by delivering a written or printed notice thereof to him or her personally or by mailing a copy of such notice in a postage prepaid envelope addressed to him or her at the post-office address furnished by the Board member to the Secretary of the Foundation for such purpose, or by transmitting such notice to him or her by fax or e-mail at the fax number or e-mail address as shall have been furnished by such Board member to the Secretary of the Foundation for such purpose. No publication of any notice of a meeting of the Board shall be required. Every notice of a Board meeting, in addition to stating the time and place of the meeting, shall also state briefly the objects or purposes thereof. Notice

of any Board meeting shall be deemed to have been waived by any Board member attending such meeting in person or by proxy. Except where otherwise required by law, notice of any adjourned Board meeting shall not be required.

(e) The Board may hold any of its meetings at such place, whether within or without the State of Delaware, as from time to time shall be designated by resolution of the Board or as shall be specified or fixed in the notice of such meeting.

(f) Meetings of the Board or of any committee of the Board may be held by means of telephonic conference or similar communications equipment allowing all participants to hear each other at the same time. In addition, at any meeting of the Board or of any committee of the Board held in person, one or more members of the Board or of such committee may participate by means of telephonic conference or similar communications equipment allowing all persons participating in the meeting, whether in person or by means of telephonic conference or similar communications equipment, to hear each other at the same time. Participation in a meeting of the Board or of any committee of the Board by means of telephonic conference or similar communications equipment shall constitute presence in person.

SECTION 9. Quorum and Manner of Action. Except as otherwise required by law, the presence of a majority of the whole Board (but in no case less than two Board members) shall be required to constitute a quorum for the transaction of business at any meeting of the Board. At any meeting at which a quorum shall be present, all matters submitted to a vote of the Board shall be decided by the affirmative vote of a majority of the Board members present. In the absence of a quorum, a majority of the Board members present at any meeting may adjourn the same from time to time until a quorum shall be had. Notwithstanding the foregoing provisions of this Section 9, however, the election of any Board member pursuant to Section 3(c) of this Article III, the

removal of a Board member pursuant to Section 6 of this Article III, the filling of any vacancy on the Board pursuant to Section 7 of this Article III or the amendment of any of the foregoing provisions pursuant to Article X of these By-Laws shall require the approval of a majority of the Board members then in office as specified in Sections 3(c), 6 and 7, respectively, of this Article III, without regard to the number of Board members present at the meeting at which such action is submitted to a vote of the Board.

SECTION 10. Action by Consent. Unless otherwise required by the Certificate of Incorporation or these By-Laws, any action required or permitted to be taken at any meeting of the Board, or of any committee thereof, may be taken without a meeting if, prior to such action, a written consent thereto is signed by all members of the Board or of such committee and such written consent is filed with the minutes of proceedings of the Board or of such committee.

SECTION 11. Compensation. Board members shall not be entitled to receive from the Foundation any compensation for their services as such, but may be reimbursed for out-of-pocket expenses incurred on behalf of the Foundation.

ARTICLE IV.

OFFICERS

SECTION 1. Number. The officers of the Foundation shall be a President, a Secretary, a Treasurer and such additional officers, agents and employees as may be appointed in accordance with the provisions of Section 3 of this Article IV. Any two offices (but not more than two) may be held by the same person, other than the offices of President and Secretary.

SECTION 2. Election, Term of Office and Qualifications. The officers of the Foundation shall be chosen annually by the Board at its annual meeting or, in the event of any vacancy in any office of the Foundation (whether because of death, resignation, removal, the creation of a new

office or any other reason), at any regular meeting of the Board or special meeting of the Board called, at least in part, for that purpose. Each officer shall hold office until his or her successor shall have been duly chosen and shall qualify, his or her death, his or her resignation or his or her removal in the manner hereinafter provided. Officers other than the President need not be Board members.

SECTION 3. Other Officers, Agents and Employees. In addition to the officers enumerated in Section 1 of this Article IV, the Foundation may have such other officers, agents and employees as the Board may deem necessary, including one or more Vice Presidents, Assistant Secretaries or Assistant Treasurers, each of whom shall hold office for such period, have such authority and perform such duties as the Board or the President may from time to time determine. The Board may delegate to any officer the power to appoint any such agents or employees.

SECTION 4. Removal. Any officer, agent or employee of the Foundation may be removed, with or without cause, at any time, by resolution adopted at any annual meeting or any regular or special meeting of the Board called, at least in part, for that purpose, or, except in the case of an officer, agent or employee appointed by the Board, by an officer upon whom such power of removal may be conferred by the Board.

SECTION 5. Resignations. An officer may resign at any time by giving written notice of his or her resignation to the Board, the President or the Secretary of the Foundation. Any such resignation shall take effect at the time specified therein or, if no time is so specified, upon its receipt by the Board, the President or the Secretary, as the case may be, and unless otherwise specified therein, the acceptance of such resignation shall not be necessary to make it effective.

SECTION 6. Vacancies. A vacancy in any office because of death, resignation, removal, disqualification or any other cause shall be filled for the unexpired portion of the term by election

at a regular or special meeting of the Board called, at least in part, for that purpose, in the case of the officers enumerated in Section 1 of this Article IV, or at the next meeting as shall be determined by the Board, in the case of other officers, agents and employees.

SECTION 7. President. The President shall be the chief executive officer of the Foundation and shall be responsible for the general and active management and direction of the business and affairs of the Foundation and general supervision thereof and over its several officers, agents and employees, subject, however, to the control of the Board. The President shall, if present, preside at each meeting of the Board. The President may sign, execute and deliver in the name of the Foundation all deeds, mortgages, bonds, contracts and other instruments. In general, the President shall perform all duties incident to the office of President and such other duties as may from time to time be assigned to him or her by the Board.

SECTION 8. Secretary. The Secretary shall, if present, act as secretary of, and keep the minutes of, all meetings of the Board in one or more books provided for that purpose. The Secretary shall see that all notices are duly given in accordance with these By-Laws and as required by law. The Secretary shall be custodian of the seal of the Foundation (if any) and shall affix and attest the seal to all documents (if any) required to be executed on behalf of the Foundation under its seal. In general, the Secretary shall perform all the duties incident to the office of Secretary and such other duties as may from time to time be assigned to him or her by the Board or the President.

SECTION 9. Treasurer. The Treasurer shall be responsible for the general care and custody of the funds and securities of the Foundation, and shall deposit all such funds in the name of the Foundation in such banks, trust companies or other depositories as shall be designated in accordance with these By-Laws. The Treasurer shall receive, and give receipts for, moneys due

and payable to the Foundation from any source whatsoever. The Treasurer shall, in general, perform all the other duties incident to the office of Treasurer and such other duties as from time to time may be assigned or delegated to him or her by the President or the Board. At its discretion, the Board may determine that it is necessary or advisable to secure, at the Foundation's expense, a bond for the Treasurer's faithful discharge of his or her duties, in which case the Treasurer shall reasonably cooperate with the Foundation in securing such bond.

SECTION 10. Compensation. The compensation, if any, to be paid by the Foundation to its officers shall be fixed from time to time by the Board. No officer shall be prevented from receiving such compensation by reason of the fact that he or she is also a Board member.

ARTICLE V.

INDEMNIFICATION

SECTION 1. General. The Foundation shall, to the fullest extent permitted by applicable law, indemnify any person who is or was made, or threatened to be made, a party to any action or proceeding, whether civil or criminal, whether involving any actual or alleged breach of duty, neglect or error, any accountability, or any actual or alleged misstatement, misleading statement or other act or omission and whether brought or threatened in any court or administrative or legislative body or agency, including an action by or in the right of the Foundation to procure a judgment in its favor and an action by or in the right of any other corporation of any type or kind, domestic or foreign or any partnership, joint venture, trust, employee benefit plan or other enterprise, or any not-for-profit entity, which any Board member or officer of the Foundation is serving or served in any capacity at the request of the Foundation, by reason of the fact that he or she, or his or her testator or intestate, is or was a Board member or officer of the Foundation, or is serving or served such other corporation, partnership, joint venture, trust, employee benefit plan or other enterprise, or not-for-profit entity, in any capacity, against, judgments, fines, amounts paid

in settlement and costs, charges and expenses, including attorneys' fees actually and necessarily incurred as a result of such action or proceeding and/or any appeal therein. Notwithstanding the foregoing, however, no indemnification shall be provided to any such person if a judgment or other final adjudication adverse to the Board member or officer establishes that (i) his or her acts were committed in bad faith or were the result of active and deliberate dishonesty and, in either case, were material to the cause of action so adjudicated, or (ii) he or she personally gained in fact a financial profit or other advantage to which he or she was not legally entitled. The foregoing right of indemnification shall not be exclusive of other rights to which any Board member, director or officer may be entitled.

SECTION 2. Reimbursements or Advancements. The Foundation shall, from time to time, reimburse or advance to any person referred to in Section 1 of this Article V the funds necessary for payment of expenses, including reasonable attorneys' fees, incurred in connection with any action or proceeding referred to in said Section 1, upon receipt of a written undertaking by or on behalf of such person to repay such amount(s) if a judgment or other final adjudication adverse to such person establishes that (i) his or her acts were committed in bad faith or were the result of active and deliberate dishonesty and, in either case, were material to the cause of action so adjudicated, or (ii) he or she personally gained in fact a financial profit or other advantage to which he or she was not legally entitled.

SECTION 3. Application of Delaware Corporation Law Indemnification Provisions. Any person entitled to be indemnified or to the reimbursement or advancement of expenses as a matter of right pursuant to this Article V may elect to have the right to indemnification (or advancement of expenses) interpreted on the basis of the applicable provisions of the General Corporation Law of the State of Delaware (or the corresponding provisions of any subsequent Delaware law

applicable to non-profit corporations) in effect at the time of the occurrence of the event or events giving rise to the action or proceeding, to the extent permitted by law, or on the basis of the applicable law in effect at the time indemnification is sought.

SECTION 4. Indemnification as Contract Right. The right to be indemnified or to the reimbursement or advancement of expenses pursuant to this Article V (i) is a contract right pursuant to which the person entitled thereto may bring suit as if the provisions hereof were set forth in a separate written contract between the Foundation and such person, and (ii) shall continue after the rescission or restrictive modification hereof with respect to any event occurring prior thereto.

SECTION 5. Proviso Regarding 501(c)(3) Status. Notwithstanding anything herein to the contrary, no indemnification shall be made if the Board, upon the advice of independent legal counsel, determines that indemnification in any specific instance would jeopardize the Foundation's status as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE VI.

CONTRACTS, LOANS, CHECKS, DRAFTS AND BANK ACCOUNTS

SECTION 1. Execution of Contracts. Except as otherwise required by statute or by these By-Laws, the President, subject to the control of the Board, may execute and deliver any contract or other instrument in the name and on behalf of the Foundation, and the Board may authorize any other officer(s), agent(s) or attorney(s) to execute and deliver any contract or other instrument in the name and on behalf of the Foundation, and such authority may be general or confined to specific instances.

SECTION 2. Loans. No loan or advance shall be contracted on behalf of the Foundation, and no negotiable paper shall be issued, endorsed or accepted in its name, unless authorized by the Board. Such authorization may be general or confined to specific instances. Any officer(s), agent(s) or attorney(s) of the Foundation thereunto so authorized may effect loans and advances at any time for the Foundation from any bank, trust company or other institution, or from any firm, corporation or individual, and when authorized as aforesaid, as security for the payment of any and all loans, advances, indebtedness and liabilities of the Foundation, may mortgage, pledge, hypothecate or transfer any property then owned or held or thereafter acquired by the Foundation, and to that end, execute instruments of mortgage or pledge or otherwise transfer such property.

SECTION 3. Checks, Drafts and Bills. All checks, drafts, bills and other negotiable instruments and orders for the payment of money issued in the name of the Foundation, and all notes or other evidences of indebtedness of the Foundation, shall be signed by such officer(s), agent(s) or attorney(s) of the Foundation as shall from time to time be determined by resolution of the Board. In the event the Board may determine that it is necessary or advisable to secure, at the Foundation's expense, a bond for any such officer's, agent's or attorney's faithful discharge of his or her duties, such officer, agent or attorney shall reasonably cooperate with the Foundation in securing such bond.

SECTION 4. Deposits. All funds of the Foundation not otherwise employed or invested shall be deposited from time to time to the credit of the Foundation in such banks, trust companies or other depositories as the Board may designate, or as may be designated by any officer(s), agent(s) or attorney(s) of the Foundation to whom such power shall have been delegated by the Board. For the purpose of deposit and for the purpose of collection for the account of the Foundation, the President and the Treasurer (or any other officer(s), agent(s) or attorney(s) of the

Foundation as shall from time to time be determined by the Board) may endorse, assign and deliver checks, drafts and other orders for the payment of money which are payable to the order of the Foundation.

SECTION 5. General and Special Bank Accounts. The Foundation may from time to time authorize the opening and keeping of general and special bank accounts with such banks, trust companies or other depositories as the Board may designate or as may be designated by any officer(s), agent(s) or attorney(s) of the Foundation to whom such power shall have been delegated by the Board. The Board may make such special rules and regulations with respect to such bank accounts, not inconsistent with the provisions of these By-Laws, as it may deem expedient.

SECTION 6. Proxies. Unless otherwise provided by resolution of the Board, the President may from time to time appoint any officer(s), agent(s) or attorney(s) of the Foundation, in the name and on behalf of the Foundation, to cast the votes which the Foundation may be entitled to cast, as the holder of stock or other securities in any other corporation the stock or other securities of which are held by the Foundation, at meetings of the holders of the stock or other securities of such other corporation, or to consent in writing, in the name of the Foundation as such holder, to any action by such other corporation, unless otherwise provided by resolution of the Board. The President may instruct the person or persons so appointed as to the manner of casting such vote or giving such consent, and may execute or cause to be executed, in the name and on behalf of the Foundation and under its corporate seal or otherwise, such written proxies or other instruments as he or she may deem necessary or proper in the premises.

ARTICLE VII.

SEAL

The Board may in its discretion provide a corporate seal, which shall be in the form of a circle and shall bear the name of the Foundation and words and figures showing that it was incorporated in the State of Delaware in the year 1990.

ARTICLE VIII.

FISCAL YEAR

The fiscal year of the Foundation shall end on the 31st day of December in each year.

ARTICLE IX.

WAIVER OF NOTICES

Whenever any notice is required to be given by these By-Laws, the Certificate of Incorporation or by applicable law, the person entitled to such notice may waive notice either before or after the time stated therein, in writing or by other appropriate means, and such waiver shall be deemed equivalent to actual notice.

ARTICLE X.

AMENDMENTS

These By-Laws shall be subject to alteration, amendment or repeal, and new By-Laws not inconsistent with any provision of the Certificate of Incorporation or of applicable law, may be made, by the affirmative vote, at any meeting of the Board, of a majority of the Board members then in office, provided that notice of the proposal to make, alter, amend or repeal any provision of these By-Laws shall be included in the notice of such meeting.
