In 2014, Room to Grow served 688 families and 734 children. These families visited the sites every three months for a total of approximately 1,800 visits, and received parenting information and support. 131 children graduated from the program during this time and 167 new babies were enrolled. The organization distributed 96,028 new and nearly-new baby items, including developmentally-appropriate toys, books, clothing and equipment. Room to Grow engaged nearly 5,000 volunteers who performed a total of 12,220 hours of work to sort, clean, fold, and display donated items and assist with other organizational efforts.
