THE MISSION OF PARK AVENUE ARMORY IS TO DEVELOP AND PRODUCE UNCONVENTIONAL WORKS IN THE PERFORMING AND VISUAL ARTS THAT NEED NON-TRADITIONAL SPACES FOR THEIR FULL REALIZATION WITH ITS PALATIAL PERIOD ROOMS BY LEADING GILDED AGE DESIGNERS AND ITS SOARING 55,000 SQUARE FOOT DRILL HALL, THE ARMORY OFFERS OPPORTUNITIES FOR ARTISTS TO BREAK THE MOLD OF TRADITIONAL PRESENTATION, ENABLING THEM TO CREATE, AND AUDIENCES TO EXPERIENCE, EPIC, AND ADVENTUROUS WORK THAT CANNOT BE DONE ELSEWHERE IN NEW YORK THE ARMORY HAS ALSO DEVELOPED A UNIQUE CREATIVITY-BASED ARTS EDUCATION PROGRAM THAT USES ITS UNIQUE ASSETS - A MAGICAL RUINED PALACE SETTING AND OUT-OF-THE-BOX ARTS PROGRAM - TO GIVE UNDER-SERVED NEW YORK CITY PUBLIC SCHOOL STUDENTS THE TOOLS TO THINK CREATIVELY AND TO LEARN HOW TO TRUST THEIR OWN JUDGMENTS

2014 was an extraordinary year for Park Avenue Armory Our non-traditional artistic offerings were spectacular and included in numerous "best of" lists in such publications as The New York Times Our arts education program for underserved public school students flourished And under the careful guidance of Herzog & de Meuron, we began the restoration of one of the most important historic interiors in the country - the Veterans Room by Louis Comfort Tiffany and Associated Artists Our artistic programming in the Wade Thompson Drill Hall saw visionary and influential artists such as the xx, Kenneth Branagh, Peter Sellars, Sir Simon Rattle and the Berliner Philharmoniker, and Douglas Gordon and Hlne Grimaud, shattering traditional expectations of performance and visual art while redefining their creative practice Every Drill Hall production this year was completely sold out - some of them selling out in just minutes - and all were as epic and immersive as ever, transporting us to a Scottish heath and henge, an ocean liner, a hill-top town, and a reflective lake The Recital Series enjoyed a successful second season, featuring internationally acclaimed musicians performing chamber music in an intimate environment as the repertoire was meant to be experienced The "Under Construction" series presented works in progress in the Armory's historic period rooms The 2014 season was attended by more than 58,000 audience members and covered widely by the press and social media The xx After headlining major festivals and huge outdoor venues like Coachella and Lollapalooza and sold-out runs at quintessential venues like Radio City Music Hall, the xx came to the Armory for a much more intimate experience Defying perceptions of a traditional concert, the Mercury Prize-winning trio created a site-specific environment that delved into uncharted levels of depth in their sound while defying scale and perception Audiences of just 45 entered the building through the 66th Street entrance, traveling through the rifle range and other areas of the building under construction to take a uniquely voyeuristic journey to the final performance space This deeply personal setting was the perfect place for the band to perform, allowing them to delve into uncharted levels of intimacy in their sound that exploded as the immense Drill Hall was revealed while redefining their relationship with the audience that surrounded them The New York times called it "[A] mesmerizing performance that often seemed as much like an art installation as a concert, and felt at every moment like a dynamic, self-aware commentary on the issue of scale " MACBETH Shakespeare's classic tale of ambition and treachery received a thrilling new life in the U S premiere of the electrifying production by Rob Ashford and Kenneth Branagh, commissioned and produced by Park Avenue Armory and Manchester International Festival Branagh, in his first Shakespeare performance in more than a decade, was joined by Alex Kingston, in their highly-anticipated New York stage debuts Utilizing the Armory's unique space and military history, this audacious staging brought to life one of Shakespeare's most powerful tragedies in an intensely physical, fast-paced production that placed the audience directly on a Scottish heath and on the sidelines of battle as the action unfurled across a traverse stage, with heaven beckoning at one end and hell looming at the other THE PASSENGER Visionary director David Pountney brilliantly staged Mieczyslaw Weinberg's landmark work, taking audiences on a voyage from the stylish deck of a luxury liner to the squalor of a Nazi death camp where cruelty, despair, and unspeakable courage are evident in equal measure Conductor Patrick Summers led the Houston Grand Opera Orchestra and Chorus and a stellar cast through the emotionally-searing score, which had been banned by Soviet authorities upon its completion in 1968, and only now made its eagerly-awaited New York premiere in a co-presentation by Park Avenue Armory and Lincoln Center Festival The production was lauded by the New York times as "harrowing and powerful a gripping production " Free prelude concerts of Weinberg's chamber music were also performed nightly by the ARC Ensemble in the Board of Officers Room for ticket holders of that evening's performance St Matthew Passion Visionary director Peter Sellars ritualized this magnificent masterpiece to create a communal grieving process in a radically inclusive approach that eliminated the separation between artist and audience, with musicians and singers moving amongst each other Simon Rattle led the Berliner Philharmoniker, a cast of superb singers including Mark Padmore, Christian Gerhaher, and Eric Owens, and extensive choral forces for the U S premiere of this epic production, co-presented by Park Avenue Armory and Lincoln Center's White Light Festival TEARS BECOME STREAMS BECOME Art, music, and architecture converged in a genre-defying, deeply moving work by Turner Prize-winning artist Douglas Gordon and acclaimed pianist Hlne Grimaud This site-specific installation featured an immense field of water that harnessed light, reflection, music, and sound to amplify and transform the Wade Thompson Drill Hall Made up of 122,000 gallons of chilled water, almost half a mile of piping, and 864 Viroc sheets, this remarkable installation - both visually and structurally - encouraged viewers to acknowledge their surroundings and reexamine one of the most historic spaces in New York For ten nights only, Grimaud performed a program of water-themed works within the space, creating a confluence of live music and visual art that allowed audiences to experience this celebrated music in a refreshingly new way The large-scale installation was also open to the public during the day, offering viewers a more meditative and reflective experience, with a player piano silently performing as both an evocation of the previous night's recital and a premonition of performances to come Recital Series The splendor of the Board of Officers Room shown through in magical recitals and concerts in 2014 that invoked the salon culture of the Gilded Age, while featuring signal works from the classical music repertoire spanning more than 250 years and performed by intrepid interpreters from New York and abroad In its second season, the reputation of the series grew tremendously, with The New Yorker claiming that "The Armory's Board of Officer's Room, recently restored to a state of spare yet sumptuous elegance, is becoming a locus for important chamber-music concerts " The 2014 Recital Series featured the U S Recital Debut of pianist Igor Levit with an all-Beethoven program, the North American Recital Debut of cellist Istvan Vardai with an all-Bach program, the FLUX Quartet in an astounding performance of Morton Feldman's six-hour String Quartet No 2, the International Contemporary Ensemble, and the U S Recital Debut of Anna Lucia Richter in an all-Wolf program Nearly 1,200 audience members attended the series Artists in Residence and Under Construction Artists-in-residence and workshops find a natural home at the Armory, and create a collaboration that benefits the artists and the Armory The program gives artists space and inspiration to work on their projects They become part of the Armory community, and every day underscore the commitment to the out-of-the-box creativity that is a basic tenet of this institution The Under Construction series features artists-in-residence sharing works-in-progress at intimate events in the Armory's jewel-like period rooms The Under Construction Series continued in 2014, offering audiences an inside look into the creative process of the Armory's artists-in-residence, who set up studios and offer intimate public previews of works-in-progress in the disciplines of dance, theater, music, and visual art The Armory's period rooms provide a unique backdrop for these workshops, serving as both inspiration and as a collaborator in the development of their works Selected by invitation, choreographer and performer Wally Cardona & Jennifer Lacey, soprano Lauren Flanigan, visual artist and choreographer Jason Akira Somma, writer Sasha Frere-Jones, and the team of Paola Prestini, Rinde Eckert, and Julian Crouch were all awarded residencies at the Armory in 2014 and were featured in the Under Construction series Education at the Armory The arts education program uses the Armory's unique assets - a magical ruined palace setting and an out-of-the-box, immersive visual and performing arts program - to give underserved New York City public school students the tools to think creatively and to learn how to trust their own judgments 2014 was a year of phenomenal growth for our arts education programs as we expanded programming, increased the number of students served, and tested a new Student Matinee model, whose success has led to the establishment of Studen
