THE TRANSITION NETWORK SUPPORTS WOMEN OVER 50 WHO ARE TRANSITIONING FROM THEIR CURRENT LIFE TO WHATEVER COMES NEXT. WITH OVER 6,000 CURRENT AND FORMER MEMBERS, TTN HELPS WOMEN CONNECT WITH EACH OTHER FOR SUPPORT AND CAMARADERIE, DISCOVER WHAT'S IMPORTANT TO THEM AND DETERMINE WHAT IMPACT THEY WANT TO HAVE ON THEIR OWN LIVES AND COMMUNITIES. TTN HELPS WOMEN EXPLORE THEIR OPTIONS AND DEMONSTRATE THAT OLDER WOMEN ARE A VALUABLE ASSET TO SOCIETY. TTN FOCUSES ON FOUR KEY OPPORTUNITIES FOR MEMBERS TO LEARN AND GROW THROUGH THEIR TRANSITIONS. THESE INCLUDE:

1. CONNECT: THESE HELP WOMEN RE-BUILD THE NETWORKS THEY MAY HAVE LOST AFTER LEAVING THEIR CAREER.
2. DISCOVER: THE MEMBERS LEARN FROM EACH OTHER IN TRANSITION PEER GROUPS AND FROM PROFESSIONALS WHO CAN HELP THEM EXPLORE THEIR OPTIONS.
3. TTN'S CARING COLLABORATIVE: PEER SUPPORT PROGRAMS RELATED TO HEALTH ISSUES.
4. IMPACT: TTN HELPS THEM SEE THE OPPORTUNITIES THEY HAVE TO MAKE AN IMPACT IN THEIR INDIVIDUAL COMMUNITIES.

	THE TRANSITION NETWORK (TTN) IS AN ORGANIZATION OF WOMEN OVER 50 WHO ARE EXPLORING "WHAT'S NEXT" IN THEIR PROFESSIONAL AND PERSONAL LIVES. AT THE END OF 2014, TTN HAS 12 FULLY OPERATING CHAPTERS SERVING APPROXIMATELY 2,100 MEMBERS. THERE ARE ALSO TWO LOCATIONS WHERE NEW CHAPTERS ARE BEING FORMED. OUR EXTENDED COMMUNITY OF ACTIVE CONTACTS (THOSE RECEIVING OUR COMMUNICATIONS OR ACTIVE IN THE ORGANIZATION AS NON-MEMBERS) EXCEEDS 7,800. TTN IS PART OF THE LARGER "POSITIVE AGING INDUSTRY" COMPOSED OF ORGANIZATIONS FOCUSED ON BABY BOOMERS AS THEY ENTER THE POST-CAREER PHASE OF THEIR LIVES. WE NETWORK AND PARTNER WITH THESE OTHER LEADING NATIONAL AND LOCAL ORGANIZATIONS, INCLUDING ENCORE ORG, COMING OF AGE, AARP, LIFE PLANNING NETWORK, RESERVE, SHIFT AMONG MANY OTHERS, IN ORDER TO BRING THEIR RESOURCES AND EXPERTISE TO OUR MEMBERS. THE MISSION OF TTN IS DELIVERED THROUGH ITS CHAPTERS WHERE WOMEN COME TOGETHER TO CONNECT WITH EACH OTHER, DISCOVER WHAT'S IMPORTANT TO THEM AND DETERMINE THE IMPACT THEY WANT TO HAVE ON THEIR COMMUNITIES. THERE ARE OVER 150 TRANSITION PEER GROUPS WHICH BRING WOMEN TOGETHER FOR LEARNING AND SUPPORT AS THEY EXPLORE THEIR CAREER TRANSITIONS. MEMBERS HAVE FORMED NEARLY 200 SPECIAL INTEREST GROUPS WHICH FOCUS ON A PARTICULAR ACTIVITY OR INTEREST, OFTEN INCLUDING AN ELEMENT OF LEARNING. IN 2014, THERE WERE OVER 300 EVENTS AND PROGRAMS ON TOPICS SUCH AS HEALTHY LIVING, MEDICARE, ISSUES RELATING TO AGING, HOUSING, BALANCING WORK AND PERSONAL FULFILLMENT, SELF-REFLECTION AND DISCOVERY, AS WELL AS PRACTICAL SKILL BUILDING - WRITING, SOCIAL MEDIA, PHOTOGRAPHY, LEGACY BUILDING. OUR MEMBERS ARE FINDING UNIQUE WAYS TO CONTRIBUTE TO THEIR COMMUNITIES. THEY COORDINATE FUNDRAISING ACTIVITIES TO SUPPORT ORGANIZATIONS SUCH AS REBUILDING TOGETHER PHILADELPHIA, PEOPLE'S EMERGENCY CENTER, ISLAND HARVEST, CAREER WARDROBE, HABITAT FOR HUMANITY AND THE BOTTOMLESS CLOSET. THEY VOLUNTEER TIME TO READ TO CHILDREN, COUNSEL MEN AND WOMEN IN THE JOB MARKET AND HELP PEOPLE COMING HOME FROM PRISON AND REENTERING SOCIETY. TTN'S CARING COLLABORATIVE IS ACTIVE IN THREE CHAPTERS. IT CONNECTS MEMBERS WHO NEED GUIDANCE AND SUPPORT AS THEY FACE A MEDICAL CHALLENGE, PROVIDE A WAY TO SYSTEM TO LEARN MORE ABOUT MEMBER EXPERIENCES AND PROVIDES PRACTICAL PEER SUPPORT FOR TEMPORARY HEALTH CHALLENGES. MEMBERS DRIVE EACH OTHER TO DOCTOR'S APPOINTMENTS, SHOP, AND PROVIDE MEALS DURING A TIME OF NEED. THE BOARD OF DIRECTORS EMBARKED ON AN AGGRESSIVE STRATEGIC PLANNING INITIATIVE IN 2014 FOCUSED ON STRENGTHENING THE INTERNAL STRUCTURE OF THE ORGANIZATION. COMMITTEES OF VOLUNTEERS WORKED ON GOVERNANCE (REISSUED TTN'S BY-LAWS), FISCAL OPERATIONS (STANDARDIZED DUES, INSTITUTED CHAPTER BUDGETING AND UPGRADED ACCOUNTING REPORTING), MARKETING AND BRANDING (MEMBER SURVEY, BRAND MANUAL AND INTERNAL COMMUNICATIONS), AND PROGRAMS (TTN'S SIGNATURE PROGRAMS). THESE SET THE STAGE FOR THE NEXT SET OF INITIATIVES FOCUSED ON GROWTH IN MEMBERSHIP AND ON DEEPENING THE MEMBER EXPERIENCE. IN 2014, TTN INTRODUCED ITS "SIGNATURE PROGRAMS." THESE ARE GROUPS OR PROGRAMS WHICH ARE UNIQUE TO TTN, DESIGNED SPECIFICALLY TO SUPPORT WOMEN IN TRANSITION. THE FIRST OF THESE IS TTN'S WOMEN IN TRANSITION, A DAY EXPERIENTIAL WORKSHOP WHICH TEACHES ABOUT THE NATURE OF TRANSITIONS AND WHAT STEPS CAN BE TAKEN TO MAKE THEM GO MORE SMOOTHLY. THIS WILL BE FOLLOWED UP BY MORE TTN-DESIGNED WORKSHOPS FOCUSING ON THE STAGES OF TRANSITION, ANTICIPATORY, NEUTRAL ZONE AND NEW BEGINNINGS. THE TRANSITION NETWORK IS REGULARLY CONSULTED BY AUTHORS, REPORTERS AND JOURNALISTS, FOR ITS EXPERTISE ON WOMEN IN TRANSITION, SEEKING A FULFILLING NEXT STAGE OF LIFE. TTN HAS BEEN FEATURED IN STORIES ON HUFFINGTON POST, NEXT AVENUE, AND WOMEN'S VOICES FOR CHANGE AND THE BOSTON GLOBE. EXECUTIVE DIRECTOR, SUSAN COLLINS, WAS INTERVIEWED ON BLOOMBERG NEWS RADIO BY CHARLES PELLETT ON THE SUBJECT OF AGEISM IN THE WORKPLACE AND APPEARED ON WOMEN AT WORK, A SIRIUS XM PROGRAM POWERED BY WHARTON SCHOOL OF BUSINESS. COLLINS WAS ALSO A PANELIST AND SESSION LEADER AT THE ENCORE ORG NATIONAL CONFERENCE. JANE PAULEY AND MARLO THOMAS PUBLISHED BOOKS AND WENT ON TOUR IN 2014. THOMAS' BOOK FEATURED THE TRANSITION STORY OF CENTRAL OHIO CHAPTER LEADER AND BOARD MEMBER, CAROL OSWALD. CAROL WAS ALSO INCLUDED IN THOMAS' HOUR-LONG LIVE PODCAST, WHICH WAS BROADCAST COAST TO COAST FOR MORE INFORMATION ON THE TRANSITION NETWORK ACTIVITIES, PLEASE VISIT OUR WEBSITE AT WWW.THETRANSITIONNETWORK.ORG
