In pursuit of this goal of developing standards, the IASB works in close cooperation with stakeholders from around the world, including investors, national standard-setters, regulators, auditors, academics, and others who have an interest in the development of high-quality global standards. The IASB develops its work programme through regular public agenda consultations and seeks formal input on the strategic direction and overall balance of its work plan. To the extent that the related accounting requirements of IFRS could have major implications for organisational costs and systems, the IASB also recognises that it must obtain robust input from its stakeholders. The IASB works in close co-operation with stakeholders from around the world, including investors, national standard-setters, regulators, auditors, academics, and others who have an interest in the development of high-quality global standards. While the IASB has a published work programme, the issuing of final Standards will be affected by the quantity and diversity of comments and specific feedback received on Exposure Drafts and Discussion Papers. It is also possible that specific interest groups or jurisdictions may raise additional issues that require further time to investigate and resolve. The timing of final Standards is therefore not completely within the control of the IASB, this can affect the costs of producing IFRS. The IFRS Foundation and the IASB provide public accountability through the transparency of their work, the consultation with the full range of interested parties in the standard-setting process, and their formal accountability links to the public. Public accountability is provided through the due process procedures which are published on the Foundation's website. Public accountability, ensured by the organization's constitution and governance arrangements, is vital to the organization's success. The IFRS Foundation's Trustees seek to ensure that appropriate governance arrangements are in place and observed by all parts of the organization. The following are some of the achievements of the IFRS Foundation in 2014. In 2014 the IASB issued the updated Standard IFRS 9 - Financial Instruments and the updated Standard IFRS 15 - Revenue from Contracts with Customers. IFRS 9 addresses issues that were raised during the financial crisis and resolves them. Several major amendments were also completed including Agriculture Bearer Plants (Amendments to IAS 16 and IAS 41), Equity Method in Separate Financial Statements (Amendments to IAS 27) and Disclosure Initiative (Amendments to IAS 1). In June 2014 the IASB began publishing an investor information advisory, The IASB Investor Update, that aims to make it easy for investors to stay informed about changes in IFRS that may affect their analysis of financial performance. Subsequently in December 2014, the IASB launched an Investors in Financial Reporting programme. The goal of the programme is to increase dialogue with the buy-side community, to ensure that IFRS continues to meet the information needs of investors globally. In July 2014, the IFRS Foundation published its first edition of IFRS as a Global Standards - a pocket guide. The book provides a summary of the use of IFRS in each of 130 countries and other jurisdictions. The summaries provide a comprehensive picture of exactly where and how IFRS is used globally. To provide a perspective on the use of IFRS, the guide also summarises what IFRS is, the benefits of global accounting standards, the IFRS Foundation and IASB structure, the history of the development of IFRS, how IFRS is developed, the requirements of current IFRS, and where IFRS resources can be found online. The summaries in the pocket guide are condensed versions of the full Jurisdiction Profiles, which are available on the ifrs.org website, and provide a snapshot of where and how IFRS is used globally. To complement the IFRS jurisdiction profiles, work has also continued on gathering data on the use of the IFRS Taxonomy. The first IFRS Taxonomy jurisdiction profiles are expected to be published on the IFRS website in 2015. From a financial perspective in 2014, the Foundation reported an operating surplus in its financial statements. This was primarily due to a decrease in operating exp</p>

During 2014, an external Operational Expenditure Review, commissioned by the Trustees, was completed by independent professional advisors. They concluded that there was a firm commitment to manage costs and achieve value for money across the Foundation. They identified many examples of ways by which the Foundation has taken positive action to reduce costs and change policy to generate savings or obtain value for money. The processes and procedures around purchasing and remuneration review were found to be appropriate for the type of expenditure incurred and the scale of the organization. No significant issues were found while conducting the review. In 2015, the IFRS Foundation will look to continue to manage its operating expenditure effectively. The Foundation will continue to look to increase its base of voluntary funding by widening the number of jurisdictions who are currently making a contribution to the Foundation. Efforts to enhance funding will ensure that the projected targets of the IASB work plan and range of services provided by the IFRS Foundation will be maintained. Efforts will continue to increase the Foundation's reserves in order to provide sufficient resources to ensure the continuity of operations. The introduction of the Accounting Standards Advisory Forum (ASAF), the establishment of regional groupings of accounting standard-setters, the introduction of more sophisticated IASB outreach and stakeholder engagement programmes, as well as the end of the convergence programme, have all led to the IASB facing a different set of challenges and priorities in the coming years. As part of the annual review cycle, the Committee meets during the year and discusses prevailing trends on compensation and remuneration. In addition, an independent global specialist remuneration consultancy firm is used to conduct detailed benchmarking of pay levels for each role within the Foundation, including all senior positions, against a large database of employers.
