

TOWNSHIP REPRESENTATIVES AND THE TRUSTEES DISCUSS AND SEEK AGREEMENT ON APPROPRIATE DISTRIBUTIONS FROM THE

THIS CONSISTENT AND SUBSTANTIAL FINANCIAL SUPPORT FROM THE FOUNDATION IS NECESSARY TO CONSTRUCT AND REHABILITATE STRUCTURES, FACILITIES AND AMENITIES IN THE PARK NEEDED TO ACCOMPLISH THE BLENDED PARK PROJECT.
