The Prior Year's Balance does not agree with the ending balance on the 2013 Form 990EZ for Silent Angels.

There were \$1,466 in supplies inadvertently not reported on the 2012 990 EZ form and therefore the 2013 990EZ form's beginning balance was also overstated by the same amount. The 2013 ending balance should have been \$50475 and not \$51941.

The 2012 ending balance should have been \$56405 and not \$57871
