Library Programs Staff Salaries. The salaries are for the Library Director and 7 Assistant Librarians (all part-time) required for provision of services to Library Patrons, the maintenance and updating of the inventory of Library circulating items, planning of special programs, and all other operations of the Library. The Library is open 31.5 hours per week, 52 weeks per year. In 2014 the total number of patron visits to the library was 9,850. The library has 1,297 registered resident borrowers and 244 non-resident registered borrowers. These figures do not include borrowers who are registered in other libraries but use the Poestenkill Library regularly for services. A Summer Reading Program, a weekly pre-school reading program, and other special programs for patrons are held throughout the year.

The total circulation for these items in 2014 was 18,260. There were 10,437 additions to Library holdings in 2014.

Library Programs Regional Library catalog and collection access. In order to provide patron access to the materials in all 29 libraries in the Upper Hudson Library System, the libraries must have a central database and a way to access that database. The regional library catalog access fee is the fee which is charged to each member library to provide and maintain that database for the year. This allows over one million items to be available to each patron in the Upper Hudson Library System and a courier system to deliver the materials from library to library. In 2014, a total of 3,064 items were borrowed by Poestenkill Library patrons through the Upper Hudson Interlibrary Loan System, and 5,930 loaned by the Poestenkill Library to other System libraries.
