IN ITS 25TH YEAR, THE AL SIGL COMMUNITY WALKABOUT INVOLVED NEARLY 750 VOLUNTEER WALKERS WHO, WITH GENEROUS CORPORATE SUPPORT, NETTED \$90,000 FOR AL SIGL COMMUNITY OF AGENCIES AND ITS MEMBER AGENCIES. PARTICIPATING AGENCIES WERE CP ROCHESTER, EPILEPSY/PRALID, INC., MEDICAL MOTOR SERVICE, NATIONAL MULTIPLE SCLEROSIS SOCIETY UPSTATE NY CHAPTER, ROCHESTER HEARING AND SPEECH CENTER, AND ROCHESTER REHABILITATION. AGENCIES RAISE MONEY FOR SPECIFIC PROGRAMS AND COLLECTIVELY TO BE SHARED BY THE GROUP.

THE 45TH AL SIGL SPORTS CLASSIC WHICH INCLUDED BOTH GOLF AND TENNIS TOURNAMENTS NETTED \$108,000 FOR AL SIGL COMMUNITY OF AGENCIES AND ITS MEMBER AGENCIES. AGENCIES RECEIVED GRANTS TO FUND EQUIPMENT AND PROGRAMS. FOR EXAMPLE, ROCHESTER REHABILITATION USED ITS GRANT FOR SPORTSNET PROGRAMS, WHICH IN 16 YEARS OF OPERATION, HAVE SERVED NEARLY 5,500 (UNDUPLICATED) YOUTH AND ADULTS THROUGH A VARIETY OF EVENTS AND ACTIVITIES. EACH YEAR, SPORTSNET DELIVERS APPROXIMATELY 4,600 SPORTS, FITNESS AND RECREATION EXPERIENCES EACH YEAR TO BETWEEN 400 AND 500 PEOPLE WITH A RANGE OF DISABLING CONDITIONS. CP ROCHESTER USED ITS GRANT TO HELP PURCHASE AN ADAPTIVE ZIP LINE FOR ITS PRESCHOOL PLAYGROUND WHICH SERVES APPROXIMATELY 100 CHILDREN ANNUALLY AND TO SUPPORT ITS "SHARED SKI ADVENTURES" PROGRAM WHICH PROVIDES ADAPTIVE SKI EQUIPMENT FOR CHILDREN AND ADULTS WITH SPECIAL NEEDS. THIS PROGRAM HAS SERVED NEARLY 1,000 INDIVIDUALS SINCE ITS FOUNDING IN 1980.
