In 2014, NAA continued its public awareness efforts by establishing an extensive social networking campaign, providing vital information, support and resources to the autism community and the general public. NAA's "Give a Voice" program provides assistive communication devices to non-verbal and minimally verbal individuals, giving them life changing and effective means of communicating their needs, wants and feelings. The program also assists with personal safety, an issue that NAA is devoted to for individuals with autism and their families. NAA distributed its Big Red Safety Boxes containing materials to help prevent dangerous wandering and elopement incidents to over 5100 families across the US at no charge. NAA provided safety training to caregivers, social workers and first responders. NAA also offered information and support through its website, toll-free line and its four day National Autism Conference featuring renowned experts.
