Phase 2 - High School Years - GSSG secures F-1 (student) visas for their students as they continue their education from the second through their fourth year of high school. During the academic year, the GSSG students live with host families. Academic and team building workshops are held each year depending on the availability of funding. At the end of each academic year, the students return to Guatemala to maintain their cultural identity. During the summers, the students often participate in service projects in their villages and towns.

Phase 3 - College Years - GSSG secures F-1 (student) visas for their students as they continue their education in colleges and universities in the USA or Guatemala. During the academic year, some GSSG college/university students live with host families, others live in dormitories or in off-campus housing. Academic and team building workshops are held each year depending on the availability of funding. Upon completion of their college education, the graduates commit to working in Guatemala for at least four years to improve the educational opportunities for the people of Guatemala.

Workshops - Each year GSSG strives to hold academic and team building workshops. The most recent workshop was held in December 2012 in Manteo, NC. This winter workshop addressed the developing relationship between Islam and Christianity.
