America's Agenda Healthcare for All updated program services in three areas during 2014 that continued our primary focus on driving higher quality, more cost-effective transformation of health care delivery centered on advanced primary care design and enhanced coordination of patient care across all care settings These updated program services respond to emergent new opportunities to advance America's Agenda's continuing mission in the changing, post-Patient Protection and Affordable Care Act ("ACA") enactment health care environment The updated program services, described in more detail with key accomplishments below, are 1 Campaign to transform delivery of health care for New Jersey public employees2 Campaign to transform delivery of care to employees across the packinghouse industry3 Call to Action to Self-funded Employer Health Plans to Lead in Transformation of America's Health Care, a campaign advanced with targeted initiatives to launch and exhibit self-funded health plan transformation of care delivery in local settings During 2014, the program to establish a Northern California Health COOP under provisions of the ACA was discontinued, because the US Congress voted to eliminate all funding for the ACA COOP program Without availability of the ACA-provided fundiont to establish ACA health care COOPs, in was not possible to continue the program The California Healthcare Education, Advocacy and Responsibility Team or "H E A R T" campaignto establish a "smart" California health care exchange came to a natural pause after the initial design of the exchange was formally adopted by the CA Exchange Board The HEART campaign was successful in achieving adoption of high-value care delivery transformation as one of the four long-run objectives of the California State health exchange, but the near-term goal for the next several years will focus, understandably, on stabilizing health plan pricing, plan participation, and administration of the new exchange In light of the redirection of the Exchange Board’s focus on exchange stabilization, HEART members opted to suspend the "smart design" campaign until a later date Detailed Program Activities In 2014, America's Agenda Health Care for All ("AAHCA") planned, developed, and launched an initiative to advocate transformation in the delivery of health care for approximately 800,000 New Jersey public employees, dependents, and retirees The initiative aims to introduce, on a large scale, innovative new strategies for delivering and coordinating high quality care at lower costs that could save hundreds of millions of dollars in State health care spending, relieving pressure to increase taxes on New Jersey residents, while producing improved health outcomes for public employees The initiative focuses on achieving changes in design of the New Jersey State Employees Health Benefit Plans, that will establish networks of advance, high-value, direct primary care health centers in communities where high densities of public employees live and work The plan design will allow private sector employers and employees to access in the direct primary care medical homes established to serve public employees, thereby dispersing the benefits of higher value care across entire New Jersey communities During 2014, AAHCA launched a coalition of New Jersey public employee unions and aligned support from other stakeholders, including New Jersey employers, patient advocate groups, and New Jersey primary care physician groups Public messaging was honed to align the interests of public sector employees and taxpayers AAHCA cultivated support among legislators and administration officials, private and public sector union leaders through direct dialogue, testimony at public hearings, and vamous policy presentations AAHCA views the New Jersey care delivery transformation project as a template for reducing public sector health care spending and driving broader care delivery transformation in other states as well In this regard, we have held preliminary discussions with Pennsylvania stakeholders about a comparable initiative in their state Beginning in 2013 and continuing throughout 2014, AAHCA carried forward an advocacy effort to persuade major corporate eployers and unionized employees in the meat packing or "packinghouse" industry to find common ground in redesigning advanced direct primary care delivery for workers at meat packing plants located in communities across several Midwestern and Western states, including Nebraska, Iowa, Minnesota, and Colorado As many of the packing house plants are the major employers in their relatively small, rural communities, our mission is to harness their potential to drive care delivery transformation that will reduce health costs and improve health outcomes for the entire populations of these communities by opening access for all local residents to advanced direct primary care that was developed, in the first stage, for unionized packing house workers Following joint discussions with packinghouse employers and unions, review of cost/savings analyses, and extensive dialog mediated and supported by AAHCA, three pilot packinghouse health centers were established 2 in Nebraska and 1 in Minnesota By the end of 2014, discussions about extending similar care delivery transformation pilots had broadened to include packinghouse employers and local unions in other states Over the course of 2014, AAHCA laid the foundation for a public Call to Action campaign challenging sponsors and trustees of self-funded, employment-based health plans that provide health care to 1/3 of all Americans to lead in high-value transformation fo America's health care AAHCA views self-funded health plans as key strategic partners that have unparalleled flexibility to adopt care delivery innovations that can reduce healthcare costs, improve care quality, and expand access to high-value health care, not only to their own participants, but across their local communities and regions Over the course of the year, the AAHCA Call to Action campaign brought together self-funded health plan trustees, major health care providers and payers, and unions representing employee beneficiaries of self-funded plans to articulate a growing consensus about guiding principles for transformative care delivery design As AAHCA prepared for public release of our Call to Action, we also earned out efforts to persuade self-funded plans to partner with AAHCA in exhibiting our guiding principles by launchin gn transformative model care delivery projects Among our achievements on this front, a highly innovative direct primary care health center was launched to serve 800 building services workers in a union and employer-sponsored, self-funded health plan in Southeastern Florida We intend for this pilot to become a hub for broader care delivery transformation in the region, and we've begun discussions with a major self-funded Miami employer to join in the initiative As 2014 closed, we were advancing toward implementation of another care delivery transformation project, implementing the same principles of transformative care delivery design with employer and union partners in Northern California As in Florida, the California pilot will be co-sponsored by employer and union partners who share our vision of opening doors of their transformative care delivery models broadly to patients, employers, workers and their families across the region
