The RiverFirst Initiative is a 20-year vision for creating the Next Generation of Parks along 5.5 miles of the Mississippi River in downtown Minneapolis. MPF’s goal is to work with the Minneapolis Park Board to realize the vision of extending the iconic string of parks and trails that line the Mississippi River further north as outlined in the Above the Falls plan. When the RiverFirst vision is fully realized, the Mississippi River will be better connected to Minneapolis neighborhoods that have not fully benefited from the Grand Rounds and legacy parks that have traditionally defined Minneapolis for generations. The Minneapolis Parks Foundation’s role is to bring private philanthropy to RiverFirst and to engage the community in order to keep this vision fresh and a priority in the city. Water Works is representative of an exciting addition to the Minneapolis Park system and a feature of the future St. Anthony Falls Regional Park. This bold new park will represent the values of this generation and those to follow as described in the Minneapolis Parks Foundation’s mission statement. In 2014, the Minneapolis Parks Foundation unveiled a conceptual vision for the site that includes a new park pavilion to serve visitor needs, better alignment of trails along the river and into the city, and better designed spaces for play, respite and reflection. Water Works is a priority park project of the River First Initiative and the Minneapolis Parks & Recreation Board’s Central Mississippi Riverfront Regional Park. This area is an important convergence of multiple riverfront destinations. MPF co-lead the design process, in conjunction with Minneapolis Park & Recreation, and wholly funded the design phase. The Next Generation of Parks Lecture Series is an ongoing program that features acclaimed urban park designers and park experts from around the world. The aim of the program is to introduce the Twin Cities community to new, engaging and critically acclaimed work that focuses on specific 21st century approaches to comprehensive parks planning and design. Minne was located in Powderhorn Park in the heart of South Minneapolis for the summer of 2014. Again this year a Facebook contest was held to have Minnes fans vote for the Minneapolis Lake in which they wanted to see her. Nearly 1,000 votes were received. Minne adds a touch of whimsy to the parks and there is a growing affinity for her presence in the Minneapolis Lakes. In the future, MPF intends to use Minne’s social media presence to promote the ecological strengths and challenges within Minneapolis’ parks and waterways.
