Other Programs The Hoarding Task Force provides trainings and case consultations related to hoarding and squalor Often, the referrals made to the BHA housing retention program are complex Many participants have multiple issues that need resolution What distinguishes the BHA Retention program from other services is the close working dynamic and access to resources that result in long-term, permanent solutions to preserve housing In 2014, we assisted 39 people with hoarding and/or squalor issues to remain housed The Farm Share Program is designated to provide fresh produce for tenants residing at the three Elderly/Disabled high-rises operated by Burlington Housing Authority In 2014, 26 individuals were served by this program The Money Camp Financial Literacy Program is a financial literacy program for children ages 10-14 The Money Camp Financial Literacy Curriculum focuses not only on the basic principles of money, money flow, financial vocabulary, financial statements, and basic investing, but also on the important concept that the beliefs and attitudes children develop about money early on in life, have a direct and lasting effect on their financial futures Unfortunately, due to extenuating circumstances, we were not able to offer any Money Camp Financial Literacy classes in 2014 We are looking forward to bringing the program back to the family developments in 2015 The Undesignated Donation Fund is allocated under the direction of the Burlington Housing Authority Director of Resident Services In 2014, approximately 200 individuals were served by this fund (Grants \$ 2,186) If this amount includes foreign grants, check here . . . ☐
