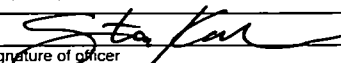

Arts & Education - The Abundance Foundation provides direct programmatic support and makes grants to organizations aligned with its mission of incubating innovative educational projects to enhance youth development through creative self-expression and the use of art to illuminate social justice issues. In 2014, the Abundance Foundation received a \$403,842 grant to provide program consultation, grant administration and administrative support for the implementation of the Agency by Design (AbD) project, an initiative of Project Zero, a research center at the Harvard Graduate School of Education under a grant agreement with the Harvard Graduate School of Education. The AbD project is a multiyear investigation of the promises, practices, and pedagogies of maker-centered learning experiences. The Abundance Foundation is providing staff support for the implementation of AbD. See Form 990, Page 2, Part III, Line 4a (continued)

Global Health Delivery - The Abundance Foundation provides program support and grants to organizations aligned with its mission to improve global health through strengthening local health systems by training, supporting and empowering local health leaders and practitioners. The Foundation supports the Global Pediatric Alliance to improve maternal and infant health in Mexico and Central America through the organizing and training of traditional birth attendants. In 2014, funding was provided for capacity building and a Small Grants Program Director who supported community-designed projects including: the building of municipal water chlorination systems in 50 rural communities that serve 5,000 indigenous families and the training in the use and maintenance of the facilities. In addition, the program trained 35 community health workers in basic health and emergency services. See Form 990, Page 2, Part III, Line 4b (continued)

Youth & Female Empowerment - Recognizing that women and youth are disproportionately impacted by war, natural disasters, economic disadvantage and violence, the Abundance Foundation focuses on youth and female empowerment as a strategy to leverage change. The Foundation provided grants to American Jewish World Service and International Planned Parenthood Federation for the implementation of violence reduction training for participants in the Haiti Adolescent Girls Network. HAGN is working to build capacity of local and international NGOs to implement girl-centered programming through training, media literacy, communications and creation of girls-only spaces and skill building camps that empower over 1,000 of the most vulnerable Haitian girls, ages 10-19 to continue to rebuild their lives following the devastating earthquake.
