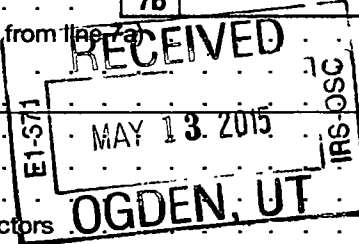

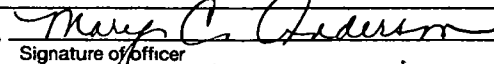

This year the families from the dump have successfully completed their agreements with Project Chacocente Acuahalínca in Nicaragua and accordingly have received the deeds to their land as well as a new electrical service monitored at each home. The school, Chacocente Christian School, continues to grow and thrive. In 2014, they served 151 students and had the first graduating class from 11th grade, the senior level. The school now serves from Pre-K through 11th grade, and continues to offer classes unavailable through public schooling: such as, religion, art, dance, music, a marching band, computer skills, and english as well as the traditional courses offered. Outreach has begun to impoverished neighbors in need of assistance.
