The Foundation each year takes a group of the foundation children to Washington DC, Pennsylvania, and New York to see universities and meet with senators and other dignitaries. This is an attempt to further educate the children as to the benefits of higher education which requires discipline. Tennis, as an individual sport, requires much mental and physical discipline.

Costs to run tournaments are additional expenses paid by the Foundation. These costs include lunches for volunteers, trophies, cost of USTA and NTA umpires, awards, photos, tennis balls, and strings.
