

PART III- 4Sarah's mission is to empower change in the life direction of women and girls who are adult entertainers, prostitutes, escorts,

or victims of sex trafficking by offering a holistic approach as well as an educational, emotional, physical and spiritual support system.

Our three largest program services is our Outreach, Intervention and Scholarship Programs. Our Outreach Program established a weekly call center to reach out to over 650 women/girls that work online as escorts on Backpage.com and other online adult sites. Our outreach team passed out over 900 gift bags to adult entertainers inside strip clubs in 2014. 4Sarah hired Jessica Lamb part time as Outreach Director.

4Sarah assisted 24 at-risk families with toys for Christmas through donations from Toys for Tots.

Our Intervention Program received over 146 hotline calls. We financially provided 16 victims emergency shelter, food or medical care.

4Sarah hired Anne Bailey part time as Intervention Coordinator to manage our 24/7 hotline to help women or girls seeking to leave their pimp, trafficker, strip club, escort agency or the sex industry. We are actively communicating with 80 women and 2 minors that plan to leave the sex industry or have entered a long term residential program.

4Sarah established a scholarship program at the end of 2013. We have awarded 13 applicants in 2014 to help women and girls continue their educate or learn a new trade other then the adult entertainment industry. 4Sarah established a scholarship committee that reviews each essay, decides if and how much each applicant should be awarded. The maximum award amount is \$2500 quarterly total for all applicants.

Kasey McClure and the 4Sarah team were invited to speak at 19 speaking engagements in 2014 to share about our mission and train individuals, companies, churches and organizations about Backpage.com and how to help victims of sex trafficking.
