Per the requirements of generally accepted accounting principles using the accrual method, we recorded revenue and the related receivable of \$250,000 for this grant. However, since we won't use the funds until 2015 and 2016, for purposes of the 990, we are going to defer the \$250,000 and show it as \$125,000 in each of 2015 and 2016 in order to match it to the periods in which it will be used for our primary program services.

Part XI, Line 4b and Part XII, Line 4b: Our audited financial statements do not reflect the in-kind donation support Compassionate Touch receives from its related organization, Lifeline Chaplaincy, by way of free use of its facilities and payment by Lifeline of the payroll of the employees of Compassionate Touch. These items are discussed in the notes to the financials, but no amounts are included in the financial statements themselves. However, these items have been calculated and included with this Form 990 Schedule R. In order to make Compassionate Touch's 990 a more complete representation of what it takes to run its operations, we have included those amounts as offsetting amounts included in income as an in-kind donation and in expenses for the amount of payroll costs and estimated facilities use costs. Thus, there is no net effect on the audited amount reported as Change in Net Assets for 2014. We feel this presents a more robust, complete presentation of Compassionate Touch's operations.

Our organization's mission is to aid seriously ill patients and their families with non-medical expenses related to a hospitalization stay, such as meals, parking, housing, etc. We

work with social workers from various hospitals in the Texas metropolitan areas to identify patients with such needs and provide funds ranging from \$50-\$350 per patient, depending

on needs. Funding is given to patients in various forms, such as cash, Visa or Wal-mart gift cards, hotel payments, hospital parking chips, etc., so not all awards are given out

in cash but all are directly valued at their cost (gift cards have a stated value, parking chips have a certain associated \$ amount, etc.); no discretion must be used in valuation.

An application is submitted to the organization by each patient desiring funds, and the application goes through an approval process. Each approved application is logged and

funding is recorded, so we are able to track the number of patients helped. In 2014, we provided assistance to 1,338 recipients with a total of \$201,895 in funding, which

is an average of \$151 per recipient; however, as stated previously, each patient may receive a different amount up to \$350 maximum per patient depending on need.
