

**Sources of Support:** Over the last 9 years, financial contributions have been received from a wide variety of public sources, including the Atherton Family Foundation, the Hawaii People's Fund, Lima Kokua Foundation, The Hawaii Conference UCC, Church of the Crossroads, UCC Judd Street Church, Whole Foods Market, the Police Activities League, CH2M Hill Foundation, North Shore Community Land Trust and many individuals.

**Availability of Public Facilities or Services:** Mohala Farms utilizes its 6-acres as a demonstration organic and sustainable farm. Both formal and informal educational tours and activities are provided to a wide variety of community groups and individual members who come to the farm. A 20' x 30' traditional Hawaiian hale is used regularly as a public meeting and discussion space. Recent groups who have used the farm grounds and/or the Hale include the Hawaii Nature Center, the Hawaii Farmer's Union, the Hawaii Vegetarian Society, the YMCA, the Boys and Girls Club, Queen Liliuokalani Children's Center, Honolulu Weed and Seed, Leeward and Kapiolani Community College's Go Farm Programs, the Waialua United Church of Christ and the Waikiki Senior Center. Dozens of individuals and families interested in organic farming are provided informal tours throughout the year.

**Public Participation in Programs or Policies:** Executive Director, Mark Hamamoto, and Board Member, Kathleen Maddux, have represented Mohala Farms at numerous public presentations, including at Neighborhood Board meetings, at the North Shore Food Summit, at GMO Awareness Community Forums and at the Hoa 'Aina O Makaha Open House.
