THE ORGANIZATION ENGAGED IN A VIGOROUS, NONPARTISAN EFFORT TO EDUCATE THE PUBLIC ABOUT ISSUES AFFECTING ARIZONA, INCREASE VOTER PARTICIPATION IN THE ELECTION PROCESS AND ALSO RAISE AWARENESS OF OUR ORGANIZATION. THROUGHOUT THE YEAR, THE ORGANIZATION MAILED NONPARTISAN CANDIDATE QUESTIONNAIRES TO PROSPECTIVE AND CURRENT CANDIDATES RUNNING FOR OFFICE AND MAILED THE RESULTS TO OVER 200,000 CITIZENS THROUGHOUT ARIZONA. THE ORGANIZATION ALSO ENGAGED IN A NONPARTISAN EFFORT TO RAISE AWARENESS OF OUR ORGANIZATION THROUGH A MULTI-WEEK TV CAMPAIGN AND THE INTERNET IN ORDER TO INCREASE CITIZEN ENGAGEMENT AND VOTER TURNOUT. AS A RESULT THE ORGANIZATION INCREASED GRASSROOTS ENGAGEMENT AND WAS ALSO MUCH MORE SUCCESSFUL IN PROMOTING OUR MISSION.

THE ORGANIZATION LED THE EFFORT TO PROMOTE MEANINGFUL PENSION REFORM IN THE CITY OF PHOENIX. THE ORGANIZATION URGED PHOENIX TO END PENSION SPIKING AND CLOSE OUT THE CURRENT SYSTEM AND TRANSITION NEW EMPLOYEES INTO A 401(K) STYLE DEFINED CONTRIBUTION SYSTEM. THE ORGANIZATION OPPOSED EFFORTS IN THE CITY OF GLENDALE TO MAKE THEIR TEMPORARY SALES TAX INCREASE PERMANENT. DUE TO OUR ORGANIZATION'S ADVOCACY EFFORTS, GLENDALE HAS NOW RESPONDED BY TAKING A CLOSER LOOK AT THEIR TAX RATES AND IS LOOKING AT OPTIONS TO ELIMINATE THE SALES TAX INCREASE. THE ORGANIZATION ALSO PROMOTED LEGISLATION TO END UNION RELEASE TIME AND END THE USE OF TAXPAYER MONEY FOR ELECTIONEERING.
