Creative Santa Fe (CrSF) is a nonprofit organization dedicated to strengthening Santa Fe, New Mexico's economy by cultivating thought leadership and by spearheading collaborative projects at the intersections of art, culture, technology, education, and industry.

Arts + Creativity Center (A+CC) - In partnership with the City of Santa Fe and others, the A+CC is envisioned as an affordable live/work/creation space where Santa Fe's creative workforce can develop individual and collaborative projects and learn entrepreneurial skills, as they transition from training to independence in the art markets. The program for the facility would also provide mentoring opportunities to prepare young creatives for the challenges of the market in Santa Fe and beyond. In 2014, the City of Santa Fe passed a resolution supporting the A+CC and entered into a \$40,000 contract with CrSF. The deliverables on the contract were to create a fundraising plan and raise \$40,000, develop a critical path timeline for the A+CC, analyze market demand, and conduct an analysis of potential sites. CrSF

4b (Code _____) (Expenses \$ 62,579. including grants of \$ _____) (Revenue \$ 2,996.)

Education and outreach - the education and outreach activities of CrSF in 2014 included "Create the Vote" and "IF: Imagined Futures". "Create the Vote" was a collaboration of arts, cultural, and creative organizations and businesses working together through non-partisan public forums to raise the issues of arts, culture, and creativity among candidates running for political office in Santa Fe. The mayoral and city council campaign gave Santa Feans the chance to discuss strengths and challenges of Santa Fe and to debate the vision for Santa Fe's future. CrSF released questionnaires to mayoral and city council candidates to clarify their position on creative economy issues. CrSF's website is also a part of CrSF's education and outreach activities.

4c (Code _____) (Expenses \$ 104,982. including grants of \$ _____) (Revenue \$ _____)

"Connect Santa Fe" - CrSF is committed to city vibrancy, cultural partnerships, supporting our distinct creative and cultural assets, and supporting youth and nightlife. CrSF is also committed to fostering connections within Santa Fe's physical infrastructure of sidewalks, streets, bike routes, trails, and urban forest, as well as social networks that provide the engine that makes Santa Fe a rich community. CrSF is currently in discussion with the City of Santa Fe to implement permanent signage and wayfinding solutions as a result of WALK [Santa Fe], which occurred in 2013. WALK [Santa Fe] was a month-long city prototyping project demonstrating simple, affordable, and practical solutions to increasing walkability in Santa Fe.
