IN ADDITION, THE PANTRY PROVIDED SUPPLEMENTAL WEEKEND FOOD EVERY FRIDAY TO AN AVERAGE OF 230 ELEMENTARY SCHOOL CHILDREN WHO DEPEND ON FREE AND REDUCED MEAL PROGRAMS DURING THE SCHOOL WEEK AND OFTEN DEAL WITH FOOD INSUFFICIENCY DURING WEEKENDS AND HOLIDAYS. TO FURTHER HELP CHILDREN IN NEED, THE PANTRY PROVIDES FREE, LUNCHES TO ALL LIVINGSTON AREA SCHOOL AGE CHILDREN, M-F ALL SUMMER. THIS PROGRAM SERVES AN AVERAGE OF 45 CHILDREN EVERY DAY.
