Scenicview Academy's employment department consists of 1 manager, 1 employment specialist, 5 employment case managers, and 5 job coaches All employment staff members have completed the Supported Employment job coaching training program offered by Utah State University The employment department provided supervision for students at 13 workstations on campus Twenty students were placed into off-campus employment settings Partnerships were developed with 7 new employers bringing total partnerships to 14 One student is actively participating in a four-year apprenticeship in maintenance at Scenicview Scenicview Academy is an approved facility to provide apprenticeships in maintenance and landscaping Twenty-five internships were set up with 14 different employers The employment department generated \$65,000 in revenue through services provided to clients of the Utah Division of Rehabilitation Services

Clinical Services provides individual and group psychotherapy services, psychological testing and recreational therapy for Scenicview Academy students Clinical staff include 6 licensed psychotherapists and 2 licensed recreation therapists In 2014, clinical staff continued to develop curriculum, media, and exercises for the social skills class and lab and participate with a local university project to research effective approaches for teaching social skills Scenicview was able to partner with both Utah Vocational Rehabilitation and Utah Valley University Passages program to provide social skills classes to their clients Recreation therapists augmented their classes with interest groups, small groups, and individual services Clinical staff provided presentations for numerous local, state, and national organizations and conferences Scenicview hosted an ethics training for staff and outside professionals

The case management program currently has 7 licensed case managers that provided over 10,100 hours of direct service to Scenicview students Case Management's health and fitness coordinator provided over 1300 hours of direct service to Scenicview students Case Management also employed 8 student drivers who provided transportation for staff and students for over 1800 hours A former Scenicview student became a part-time Scenicview employee assisting with transportation needs of the students The manager of the case management unit served on the board of directors for the Utah Chapter of the Learning Disabilities Association of America Scenicview's part-time nurse provided nearly 200 hours of nursing services to students management department driving other students to appointments and on errands and staff to the airport In 2012, eight student drivers provided rides for students and staff for a total of 2,414 hours
