SPONSORSHIP PROGRAM FOR WIDOWS AND ORPHANS The genocide of 1994 left Rwanda with a disproportionate numbers of widows and orphans ERM created "families" by putting these survivors together ERM provides support (food, clothing) for the women and children, and funds for school fees In 2014 the ERM widows/orphans program supported 10 widows and 45 orphans

HOPE VOCATIONAL TRAINING CENTERS In 2008 ERM established a vocational school near Kigali, the capital of Rwanda The school offers training in carpentry, sewing, welding, construction and hair dressing, within a faith-based context In 2014 the school received accreditation by the Rwanda government, which further enhances the certificate that each graduating student receives In 2014, the school trained 100 students from a World Vision program and graduated 139 other students In 2013, ERM began a second school in Rugendabari, offering sewing classes That campus graduated 26 students in 2014 In 2014 ERM built an addition at the Kigali school for a computer lab, and began fundraising for an additional school building
