MUDITAR LED INITIAL VILLAGE MEETINGS TO DISCUSS PARTNERSHIP PRINCIPLES, EXPLORE VILLAGE STRENGTHS AND WEAKNESSES, ELECT 12 WOMEN AND MEN TO VILLAGE DEVELOPMENT TEAMS (VDT) AND DETERMINE VILLAGE NEEDS AND PRIORITIES. MUDITAR THEN MET WITH THE VDT'S ON A MONTHLY BASIS FOR PROJECT PLANNING, SKILLS TRAINING, AND MENTORING MEMBERS.
