Microchurch planting Our main service as organization is to help initiate and grow microchurches reaching different groups of people in the city In 2014, we grew to about 120 microchurches Some of our microchurches are need based and are engaging people in the margins They form community around a shared calling of meeting a certain need or addressing a certain dispersed group of people They raised their own support from outside of the Underground to pay their staff and to accomplish their vision It also supports a microbusiness that provides training and skills for clients of one of microchurches
