These grants provided school fees, spiritual education, food, shelter, and clothing for the children.**4b** (Code: N/A) (Expenses \$ 51,828 including grants of \$ _____) (Revenue \$ _____)Travel Expenses - Lahash alerts, trains, and facilitates volunteers to our partner locations across East Africa.
