(When possible, we also help the woman receive assistance from other organizations.) The general maximum amount of financial assistance from Women Partnering is \$250. Staff have the option of an additional \$250 for exceptional circumstances/good cause. Any amount over \$500 should be approved by the Board. The case must be documented thoroughly and the outcome must be positive & predictable. The assistance must have a good risk-ratio & should not exceed the given threshold. The funds are paid directly to the provider group/person, never directly to the woman. Receipts are expected. All transactions are logged in Quickbooks & each woman's file. Transportation stipends (\$5) and childcare stipends (\$10) are given each time a woman participates in most enhancement programs, after she completes a measure tied to growth in knowledge, skill and behavior. Each woman must date, sign, and identify amount received and program attended.
