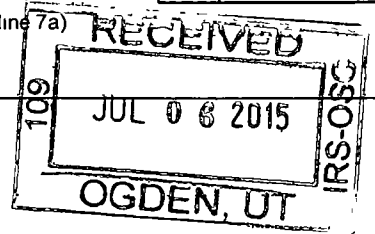

TRFW chapter in Benton County provided access to low cost inputs for small farmers, community gardens and home gardeners via the annual Soil Amendment Sale. A total of 125 farms/community gardens/individuals were served in 2014.

A farming skills workshop was organized in 2014 for the first time and reached 10 households to learn fruit tree grafting techniques. Monthly Education talks and demonstrations about food growing, soil health in the context of gardening, homesteading and small farming were provided to over 50 families over the course of 2014.

TRFW started and administered the Seeds to Supper program in 2014 and reached 20 households with hands on skills training in both gardening and food preparation.
