

In 2014, Able Flight awarded a total of ten scholarships to people with physical disabilities, including wounded veterans. Recipients included three wounded veterans, three people paralyzed due to accidents, one who lost a limb due to an accident, one with Cerebral Palsy and one with a congenital spinal condition.

Able Flight scholarships for 2014 included six for flight training (all six students earned FAA-issued pilot certificates), and four for aviation career training. The flight training students attended Able Flight' annual joint training program and Purdue University's Department of Aviation Technology.

The flight training scholarships covered all expenses including flight and ground school, travel and lodging, books and manuals and testing fees. For 2014, the aviation career scholarships supported university tuition and fees and technical training. In 2014, through attendance at four major aviation events, Able Flight provided mentoring and information resources for people with disabilities interested in entering aviation either as pilots or to seek aviation careers.

Able Flight maintains a regularly updated website (www.ableflight.org), publishes a monthly newsletter, and uses social media and traditional print and digital media for outreach to potential scholarship candidates.
