

Retreat Program -- TEF provides retreats for the families of people with disabilities. These retreats are provided for the families free of charge. The retreats offer refreshment and biblical encouragement for the families and for those experiencing disability. A balanced schedule of workshops and activities for the family, as well as for each individual, provides a refreshing and fun environment for the entire family. Retreats are hosted in partnership with local churches to serve as an outreach into the special needs community, to compliment a church's existing disability ministry, or as a launch for a new disability ministry. In 2014, a retreat was provided in Washington state, which served 11 families and had 30 volunteers.

4b (Code:) (Expenses \$ 36,024 including grants of \$) (Revenue \$ 0)

Reach Program -- This program serves families of people with disabilities around the world. In 2014, TEF served 33 families in Azerbaijan through camps and provided counsel to Azeri Christian workers on how to further develop disability ministry in their community. TEF also led a team of students on a three week trip to the Republic of Tuva in Russia to help local missionaries with disability outreach in the area. Training in special education was also provided for teachers and the director of an area school.

4c (Code:) (Expenses \$ 71,857 including grants of \$) (Revenue \$ 5,075)

TEF Conference -- TEF held a conference for parents and care providers of people with disabilities. Sessions were led by speakers who are also parents of children experiencing disability. This provided for very rich and meaningful instruction that was highly applicable to parents and caregivers alike. While registration fees were charged for this event, many attendees were provided with a partial or full discount through the generous support of donors. The conference served 30 families and was staffed with 15 volunteer. In all, 80 attended the conference and benefited from this unique opportunity for encouragement and networking.
