At least 170 volunteers stayed with us for a week this year in our center in Nogales, Mexico. We also held events in Virginia, Arizona and Ireland. The dollars were used primarily for food, lodging and transportation.

4b (Code: n/a) (Expenses \$ 27,815 including grants of \$ 0) (Revenue \$ 0)

The volunteers mentioned about spend 6-7 hours each day on work projects in the neighborhood surrounding our center in Nogales, Mexico. The dollars are primarily spent on constuction supplies. Our projects include retaining walls, cement floors and house painting.

4c (Code: n/a) (Expenses \$ 46,685 including grants of \$ 0) (Revenue \$ 0)

Over the last 10 years, the volunteers mentioned above have helped us construct soup kitchens in Mexico. Although the volunteers usually come for one week a year, these ministries run year round. We are currently serving food once a week in five locations. In addition we have a sports park and a homeless shelter. These dollars are dispered on a monthly basis to leaders in Mexico who are responsible for running the programs.
