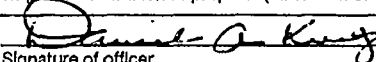

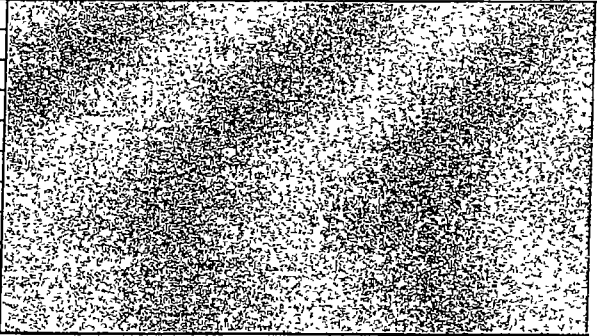

Periodic financial reports from the Burundi office are provided to the US President and treasurer. The President, Chief Operating Officer and other US staff take periodic trips to Burundi and have opportunity to see first hand how funds are being used. An independent audit of the Burundi financial records is performed annually and reported to the US board.

Recipients of sponsorship funds or houses are profiled by our social workers and home administrator to provide a needs assessment prior to connecting a widow with a sponsor or providing a home.

Micro-enterprise loan fund records are maintained by the Burundi administrator of the program and reported to the Chief Operating Officer, President, and treasurer.
