RAIL TRAIL DEVELOPMENT These program expenses were primarily local match funds for rail trail development. The majority of these funds were raised and expended for 1 1 mile phase of the Salem Bicycle and Pedestrian Corridor in Salem, NH. See www.fsbpc.org. The monies expended in 2014 were given to the Town of Salem as matching funds for a Federal Transportation Enhancements program grant administered by the NH Dept. of Transportation. The rail trail in Salem is part of a larger vision called the Granite State Rail Trail which aims to create a trail from the Massachusetts near Salem, NH to the Vermont border near West Lebanon, NH. The Salem Bicycle Pedestrian Corridor project has been awarded a Federal Transportation Alternatives Grant to support Phase 2 of the project. Fundraising for match money in support of that project is ongoing. Another rail trail expense in 2014 was in support of the Concord-Lake Sunapee Rail Trail. This expense supported development of a 1/2 mile segment of trail in Warner, NH in the middle of what could be a 34 mile trail from Concord to Newbury.
BWANH provides technical assistance, support and coordination for local groups along these corridors and other rail trails in NH.

4b (Code:) (Expenses \$ 34,710 including grants of \$ 21,500) (Revenue \$ 1,345)
SAFETY & EDUCATION PROGRAMS In 2014 BWANH through the Central New Hampshire Bicycle Coalition donated funds to the City of Concord so the city could purchase stencils and paint bike lanes on 5 miles of North State St. greatly improving the safety of cycling in this corridor. Concord has earned the designation of "Bicycle Friendly Community - Bronze Level" from the League of American Bicyclists. See <http://bikeleague.org/community>. One of the measured metrics is "arterial streets with bike lanes" (<http://bikeleague.org/sites/default/files/BFC%20infographic.pdf>) and this expense helps Concord in its goal to maintain and improve its bicycle friendly community status.

BWANH also provides bicycle education to adults and to children through the training of adults to teach youth classes.

4c (Code:) (Expenses \$ 5,304 including grants of \$ 500) (Revenue \$)
BICYCLING RECYCLING PROGRAMS This expense was in support of a program in partnership with Goodwill Industries of New England that provides employment training in the bicycle industry. Recycled Cycles repairs donated bicycles and sells them at the Concord NH Goodwill store and at a local bike swap. The goals of the program are to provide employment to women transitioning to work release and to provide a source of low cost bicycles for people in the Concord area. Another BWANH program recycling bikes is the Laconia Area Bicycle Exchange. In 2014 LABE donated 100 bicycles to needy members of the community. The main focus of the program is supplying adults with bicycles for transportation so they can get to employment and run errands. For more information see <http://labebike/>.
