**CLIMATE CHANGE: SINCE 2009 MBB HAS BEEN AN OFFICIAL OBSERVER ORGANIZATION FOR THE UNITED NATIONS FRAMEWORK CONVENTION ON CLIMATE CHANGE (UNFCCC). IN 2014 THE CLIMATE CHANGE TEAM MADE 3 TRIPS (JUNE, OCTOBER AND DECEMBER) AND 6 MBB MEMBERS TRAVELLED. THE TEAM HAD MULTIPLE MEETINGS WITH VARIOUS ORGANIZATIONS AND COUNTRY REPRESENTATIVES REGARDING THE UTILITY AND APPLICATION OF MEDIATION AS A PRIMARY TOOL IN DEALING WITH THE INTRACTABLE CONFLICTS THE UNFCCC WAS FACING IN THIS REGARD, WE HIGHLIGHTED OUR SUCCESS IN THE CONSTRUCTION OF LANGUAGE THAT INCLUDED "MEDIATION" AS A PROCESS EN PAR WITH OTHER MODES OF DISPUTE RESOLUTION.
