The building will be a secluded and secure environment within the nunnery where senior nuns will be able to meditate intensively during the traditional 3-year Buddhist retreat. The grantee is required to track all funds and make semi-annual reports on progress.4b (Code:) (Expenses \$ 29,959. including grants of \$ 25,000.) (Revenue \$)Grant supports Konchok Foundation, a Colorado 501c3 corporation, for construction of a shedra, a monastic college, in Eastern Tibet, replacing structures destroyed in the 1950's. The grantee is required to track all funds and make semi-annual reports on progress.4c (Code:) (Expenses \$ 28,926. including grants of \$ 24,137.) (Revenue \$)The Foundation's "Book Initiative" program purchases and gives books, CDs and DVDs of Buddhist teachings and meditation instruction by its founder, Pema Chodron, to underserved populations. During the year it has given about 1,100 books, CDs and DVDs to a variety of groups and individuals around the world. About 750 to 1,000 individuals have benefitted. Some of the agencies that have benefitted are cancer recovery groups, prison support groups, addiction recovery groups, AIDS clinics, and homeless shelters. It has been found that the Buddhist teachings can be especially helpful to people experiencing intense suffering. Other program service activities include contracts for publishing of books, CDs, and DVDs on meditation; support for a nunnery in Nepal, for an American nun, for a Western Buddhist monastic gathering, and for a digital monastery project.
