First Step Staffing contracts with employers and then directly employs men and women to fill those contract jobs. To help them successfully re-enter the job market, First Step provides training, job coaching, transportation to work, and any necessary uniforms, tools, or equipment. First Step has had a powerful impact on individuals' lives and in the community. Since it started in 2007, First Step Staffing has helped over 2,100 people re-enter the workforce. Cumulatively, they earned over \$4,000,000 on First Step's payroll and they paid over \$700,000 in payroll taxes.

First Step Benefits was implemented to help men and women with severe disabilities access Social Security Disability Income (SSI) and Medicaid. Prior to First Step Benefits, only 19% of homeless people who applied for disability were approved. In contrast, over 80% of First Step's clients are approved and in an average of 120 days (compared to 3 - 5 years in Georgia). First Step Benefits has secured Social Security Disability income for over 1,100 participants and they have a combined annual income of over \$8,900,000.
