The ABF follows policies and procedures designed to maximize the effectiveness of grants, as well as ensure the grant funds are used for an exempt purpose. These policies and procedures are applied consistently for grants in and outside the United States. All grants go through a pre-grant inquiry process where the grantee is required to provide extensive information on its governance practices, financial policies and program activities in general, as well as with regard to the specific program for which it is requesting funding. A formal grant agreement is then executed and countersigned by the grantee and the ABF. The grant agreement specifies the amount of the grant, grant disbursement time line, any restrictions on the grant, as well as that the grant funds must be separately accounted for by the grantee. Grantees must report back to the ABF prior to receiving release of periodic grant installment disbursements. The ABF usually makes grants in several installments to ensure compliance with program, operational and accounting requirements by the grantee organization. The grantees provide interim operational and financial reports to the ABF. The reports describe the progress in achieving the grant objectives and include detailed accounting of the uses or expenditures of all grant funds. The program directors and the evaluation team of the ABF review the interim reports and conduct site visits to ensure that the progress indicated in the reports is correct. The ABF Finance and Compliance function reviews the interim financial reports and supporting records, such as invoices and contracts. The grantees provide a copy of audited financial statements for the accounting period covering the grant, if such are available. The grantees also submit a written report summarizing the project within two months after completion of the project in which they include a complete account of the expenditures of the grant funds and detailed description of the results and accomplishments of the grant. The grantees are required to keep financial records with respect to each grant along with copies of any reports submitted to the ABF or at least two years following the year in which all grant funds are fully expended. The ABF Audit Committee and Board of Directors exercise oversight over the grants disbursed through the review of reports and presentations by management.

Grants are reported consistent with the ABF's financial statements using the accrual method of accounting. Grant expenditures are recognized in the period the grant agreement is signed by ABF and the grantee, provided the grant is not subject to future contingencies. Conditional grants are recognized as grant expense and as a grant payable in the period in which the grantee meets the terms of the conditions. If payments of the unconditional promise to give are to be made to a recipient over several fiscal periods and the recipient is subject only to routine performance requirements, a liability and an expense for the entire amount payable is recognized. Investment expenses are reported consistent with the ABF's financial statements using the accrual method of accounting.

All companion travel serves a bona fide business purpose and, therefore, these expenses are excluded from the Director's taxable income as a non-taxable working condition fringe benefit. Accordingly, the ABF does not deduct its payments of the Director's companion travel expense on its tax return.

*In 2001, the Board of Directors of the Bulgarian American Enterprise Fund (the Fund), which is a related organization, adopted a long-term equity incentive plan (the Plan) for certain employees of the Fund and its subsidiaries. The Plan, as approved by Congress and USAID, became operational October 1, 2001 and provides for participation in returns achieved upon exit of specified equity investments. Plan participants are subject to a vesting requirement of 20% per year, which accelerates to 100% at the time of exit of a Plan investment. The Audit Committee of the Board of Directors supervises the administration, investment valuations, and awards under the Plan. Plan participants include five US citizens and thirty-two Bulgarian employees. Participations recorded in the Fund's consolidated statements of operations and changes in fund balance in 2014 were approximately \$381,000. The amounts noted as compensation from related organizations in column B(ii) above are comprised primarily of payouts from their participation in the Plan. These amounts are reported on forms 1099 and K-1.

The initial Class I, Class II and Class III Directors shall be those Directors designated as such in Article Ninth hereof. At each annual meeting of the Members, Directors to replace those of a class whose terms expire at such annual meeting shall be elected to hold office until the third succeeding annual meeting thereafter and until their respective successors shall have been duly elected and qualified. If the number of Directors is hereafter changed, any newly created directorships or decrease in directorships shall be so apportioned among the classes as to make all classes as nearly equal in number as practicable. The election of Directors need not be by written ballot. Any Director may be removed at any time, with or without cause, by a vote of a majority of the Members. Any vacancy occurring on the Board of Directors of the Corporation may be filled by a majority of the remaining members of the Board of Directors of the corporation, although less than a quorum, at any meeting of the Board of Directors of the Corporation. Any Director elected to fill any vacancy on the Board of Directors of the Corporation shall be elected to serve the unexpired term of the directorship".

In particular, a Director of the ABF shall recuse him/herself from the Board's deliberations regarding any matter in which the Director has a conflict of interest unless the Co-Chairmen or a Chairman of the Board determines that recusal is unnecessary in the particular instance. In addition, an employee shall not be the responsible staff person on a transaction in which he/she has a conflict of interest.

The process for determining compensation for the President, Executive Director, and CFO comprises studies of comparative data, review of Form 990 for other organizations, approval by independent persons, and annual review. The process for determining compensation for all other employees includes a market study, annual review and approval by the Audit Committee.
