Limuru Children's Centre (LCC): Completed Baby Home division that houses 12 abandoned or sick infants waiting for adoption. The Godparent program continues to provide financial support, assistance in reading and writing English, and enhances relationship skills in addition to providing home to 59 children. The LCC provides education opportunities to 281 children. Mrs. Pat Dixon has helped many children with her compassion, support, wisdom and direction. She brings toys to children in the hospital, hundreds of blankets to the children of the community and a bimonthly feeding program. Mrs. Dixon is a British native of Kenya. Global Connections has leased a ten acre compound for use as a farm. The farm is set up for vegetables, with chicken houses, calf or hog parlors,

Rafikifriends serves the children at Methodist Rafiki Satellite Village in Ghana, Africa. Rafikifriends partners with the Methodist Rafiki Satellite Village to help support their needs by providing monthly sponsorship, annual fundraising, and the sending of students from the MSU Wesley Foundation to serve alongside the staff there. Through the work of Rafikifriends, the number of children rescued by the orphaage has increased from 6 children in 2008 to 32 children in 2013.

Uhuru Kuku "Freedom Chickens" is a chicken farming business that will be supplying chickens every 7 weeks. We have broken ground on this project, have dug and laid a 1 mile water pipeline and have started building the chicken house. Uhuru Kuku will be fully operational and has the potential to create jobs and educate families to become self sustaining. Our goal for next year is to expand Uhuru Kuku which we can use for further development and educational initiatives on the ground in Kenya.
