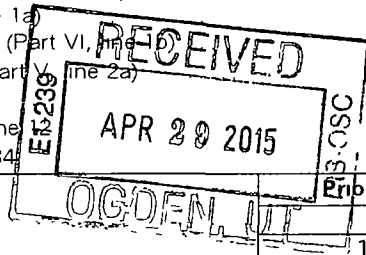

MUTUAL RELEASE AND COVENANT NOT TO SUE

This Mutual Release and Covenant Not to Sue is entered into between First Midwest Bank and The Housing Authority of the City of North Chicago.

WHEREAS, certain disputes have arisen between First Midwest Bank, an Illinois banking corporation ("First Midwest") on the one hand and the The Housing Authority of the City of North Chicago, a municipal corporation duly organized and existing under the Illinois Housing Authorities Act, 310 ILCS 10/1, et. seq., on the other hand ("Housing Authority"), which dispute concerns the rights, duties and obligations of each party to the other arising out of a series of loans made by First Midwest to Self-Sufficiency Development Corporation, an Illinois Not For Profit Corporation ("Self Sufficiency"); and

WHEREAS the parties hereto agree that nothing contained in this Mutual Release and Covenant Not to Sue is to be construed as an admission of guilt, fault or liability by any party; and

NOW, THEREFORE, for and in consideration of the release of any and all claims by First Midwest against the Housing Authority and the release of any and all claims by the Housing Authority against First Midwest and other good and valuable consideration the receipt and sufficiency of which is approved the parties hereto agree as follows;

RELEASE BY FIRST MIDWEST

KNOW ALL MEN by these presents that First Midwest, and their successors and assigns, for good and valuable consideration, receipt of which is hereby acknowledged and the sufficiency and adequacy of which is hereby confessed, does hereby release, remise, forever

discharge and covenant not to sue the Housing Authority, their officers, directors, attorneys, employees, predecessors, successors, affiliates, parents, subsidiaries and assigns, from and for any and all manner of liabilities, claims, causes of actions or suits at law or in equity which they, their successors and assigns, now have, or may have had arising out of, or in any way connected with the fact or circumstances which were, or could have been asserted in regard to a series of loans made by First Midwest to Self Sufficiency, as well as any other claims or causes of action which arise directly or indirectly in regard to such loans, or otherwise, the parties intending that this constitutes a general release of any and all claims pre-existing the date of these presents, without any limitation of any kind or nature whatsoever.

By execution hereon, First Midwest represents and warrants that to the extent approval may be required, it has been obtained and accordingly this Mutual Release and Covenant Not to Sue has been executed knowingly and that First Midwest has been fully advised by its counsel of the legal and practical effects of this document, that there has been no assignment of any rights, claim or cause of action encompassed by this Agreement to any individual, corporation or other entity whatsoever. It is specifically intended that this document constitutes a full and irrevocable release of any claim asserted or to be asserted by First Midwest against the Housing Authority.

RELEASE BY THE HOUSING AUTHORITY

KNOW ALL MEN by these presents that for itself, its officers, directors, legal representatives, successors and assigns, for good and valuable consideration, receipt of which is hereby acknowledged and the sufficiency and adequacy of which is hereby confessed, the Housing Authority does hereby release, remise, forever discharge and covenant not to sue first Midwest and their assigns, from and for any and all manner of liabilities, claims, causes of

actions or suits at law or in equity which it, its successors and assigns, now has or have, or may have had arising out of, or in any way connected with the fact or circumstances which were, or could have been asserted in regard to a series of loans made by First Midwest to Self Sufficiency, as well as any other claims or causes of action which arise directly or indirectly from any of such loans, or otherwise, the parties intending that this constitutes a mutual and general release of any and all claims pre-existing the date of these presents, without any limitation of any kind or nature whatsoever.

By execution hereon, the Housing Authority represents and warrants that to the extent approval may be required, it has been obtained and accordingly this Mutual Release and Covenant Not To Sue has been executed knowingly without promises or threats or the exertion of duress and that the Housing Authority, has been fully advised by its counsel of the legal and practical effects of this document, that there has been no assignment of any rights, claim or cause of action encompassed by this Agreement to any individual, corporation or other entity whatsoever. It is specifically intended that this document constitute a full and irrevocable release of the claims asserted by the Housing Authority against First Midwest.

GENERAL

Counterparts. This Mutual Release and Covenant Not to Sue may be executed in counterparts, each of which so executed shall, irrespective of the date of its execution and delivery, be deemed an original, and said counterparts together shall constitute one and the same instrument. This document may also be executed by way of facsimile or e-mail signature and such signature shall be sufficient to bind the party so executing this document.

Entire Understanding. This agreement contains the entire understanding of the parties with respect to the transactions contemplated hereby and supersede all other agreements and understandings of the parties and the subject matter hereof. In the event that any portion of portions of this agreement is or are declared unenforceable or null and void as a violation of public policy, the remaining portions shall remain in full force and effect as though the offending portions were never a part of the agreement.

Illinois Law. This agreement shall be interpreted, construed, and enforced according to the laws of the State of Illinois, without giving any effect to any conflict of law provisions, and both parties hereby expressly submit themselves to the jurisdiction of any court of competent jurisdiction within the State of Illinois with respect to any and all claims, demands or causes of action asserted or filed by either party relating to, or arising out of, the subject matter of this agreement.

Confidentiality. This Agreement and all matters relating to the terms and negotiations of this Agreement shall be confidential and not to be disclosed to any person or entity without the prior written consent of the Parties hereto; provided, however, that the terms of this Agreement may be disclosed (1) to any person as required by law; and/or, (2) to the extent reasonably necessary, to each Party's directors, officers, board members, employees, attorneys, members, managers, auditors, bankers, and accountants; and/or (3) as is necessary or is required for obtaining tax, legal, or financial advice. This Agreement and all matters relating to the terms and negotiations of this Agreement may also be disclosed by any Party in any action or proceeding to enforce this Agreement.

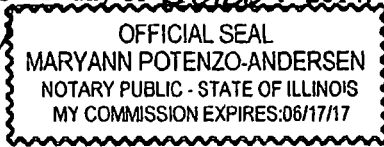
