OK Humane has implemented several programs over the last seven years to reduce euthanasia at the Oklahoma City Animal Shelter. In 2014, 24,324 dogs and cats were received at the Oklahoma City Animal Shelter. Over 8,000 of these dogs and cats were euthanized. A key component to addressing this overpopulation crisis is to ensure that animals received at the Oklahoma City Animal Shelter are placed into new homes through adoption or transferred to other partner animal welfare organizations. Since launching the OK Humane Adoption Program in 2007, OK Humane has opened a successful Adoption Center and performed over 18,000 adoptions. In 2014, the OK Humane Adoption Program found homes for 3,750 dogs and cats.

In an effort to reduce the intake of animals into the shelter, OK Humane implemented a low-cost spay/neuter program which has been well-marketed and made easily accessible to the public. The OK Humane Spay/Neuter Program operates one clinic and has performed more than 70,000 sterilizations, 10,480 of which happened in 2014. Another significant spay/neuter effort is OK Humane's Trap-Neuter-Return Program for feral cats. The program began when OK Humane was founded in 2007, since then more than 7,600 cats have been sterilized.

In April of 2014 the quarantine facility was repurposed to house adoptable dogs. The facility currently functions as the hub for all intake of animals transferred in from the Oklahoma City animal shelter.
