## Part III Line 4a Statement of Program Service Accomplishments

### Message from the President

The highlight of 2014 was the Alltech FEI World Equestrian Games™ (WEG) in Normandy, France. Team USA achieved excellence, winning seven medals including Reining – Team Gold, Shawn Flarida/Individual Gold, Andrea Fappani/Individual Silver and Mandy McCutcheon/Individual Bronze, Driving – Chester Weber/Individual Silver, Jumping – Team Bronze and Beezie Madden/Individual Bronze.

In support of the enormous undertaking of WEG, the USET Foundation provided \$3,231,185 in funding. This funding was critical to the preparation and transport of a U.S. delegation consisting of 53 athletes, 117 support staff and 52 horses to Normandy for a month to train and compete. This was only possible through our loyal and generous donors whose charitable gifts have made the USET Foundation the single largest source of revenue to the USEF High Performance programs.

The Foundation's headquarters, Hamilton Farm in Gladstone, NJ, remains an important component of the High Performance programs, from housing USEF High Performance staff, Team USA equipment and horse clothing to hosting the George H. Morris Gladstone Program for up-and-coming talented Jumping riders, Dressage and Para Dressage National Championships and WEG selection trials. Hamilton Farm also served as the location for several of the U.S. teams assembling for their final training and preparations prior to flying to Europe for the Games.

Our most important fundraising effort, the Campaign for Continuing Our Competitive Excellence, is in the final stretch, having raised \$30,000,000 towards the \$35,000,000 goal by the end of 2014. We are hopeful that with the support of many more individuals who are passionate about equestrian sport, we will achieve our goal in the coming year.

While we must continue to be diligent in our fundraising activities, we are grateful and proud of the fact that since its inception in December 2003, the USET Foundation has provided over \$25 million in support to the USEF High Performance programs and has matured into a charitable organization recognized by Charity Navigator with its coveted 4-Star Rating for good governance, sound fiscal management and commitment to accountability and transparency.

Thank you for making 2014 a great year and for your continued commitment to our United States Equestrian Teams and the High Performance programs that will put our athletes on the podium.

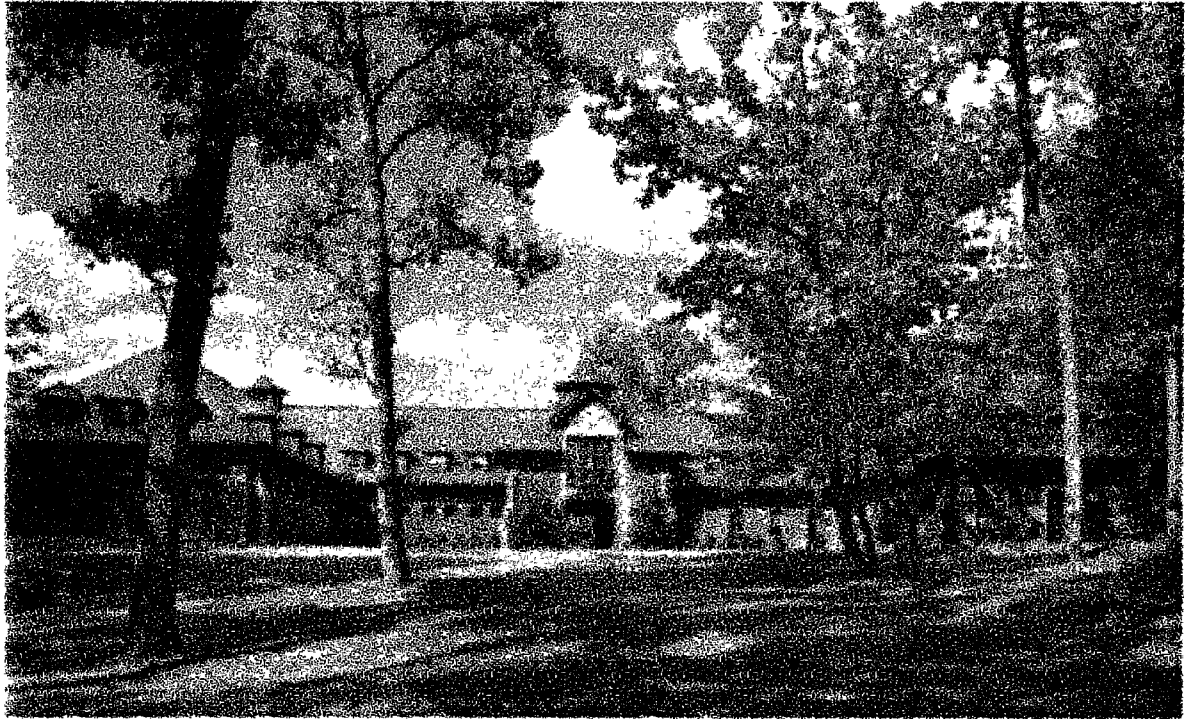

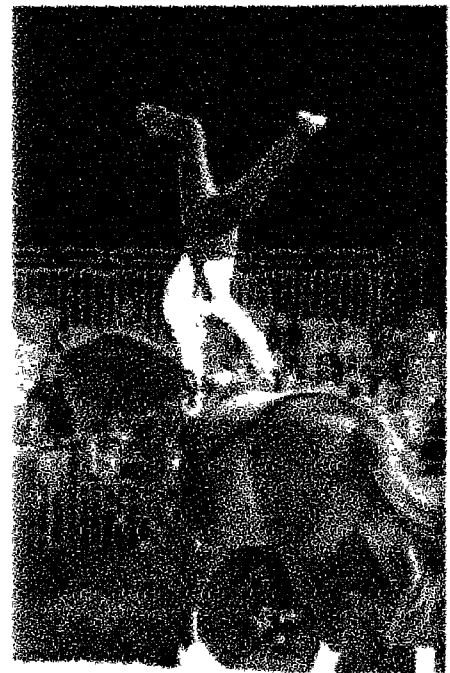


## Vaulting

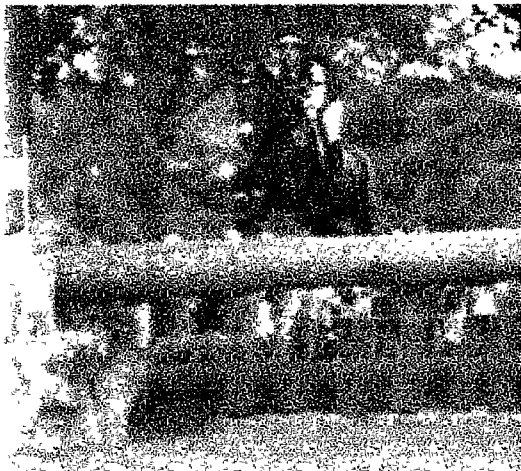




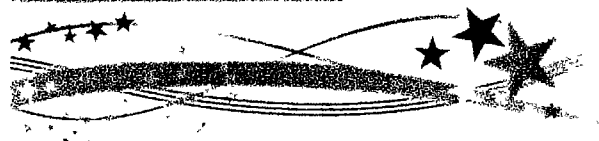
## Eventing

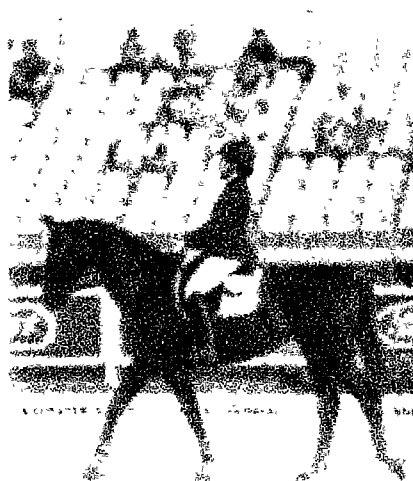
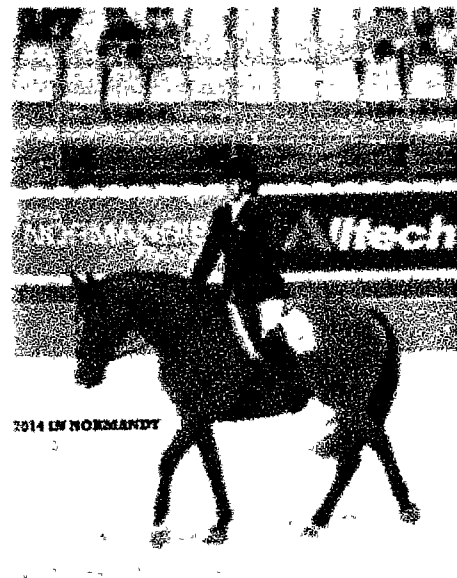




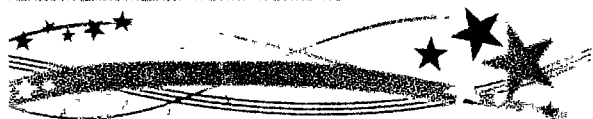
## Para Dressage

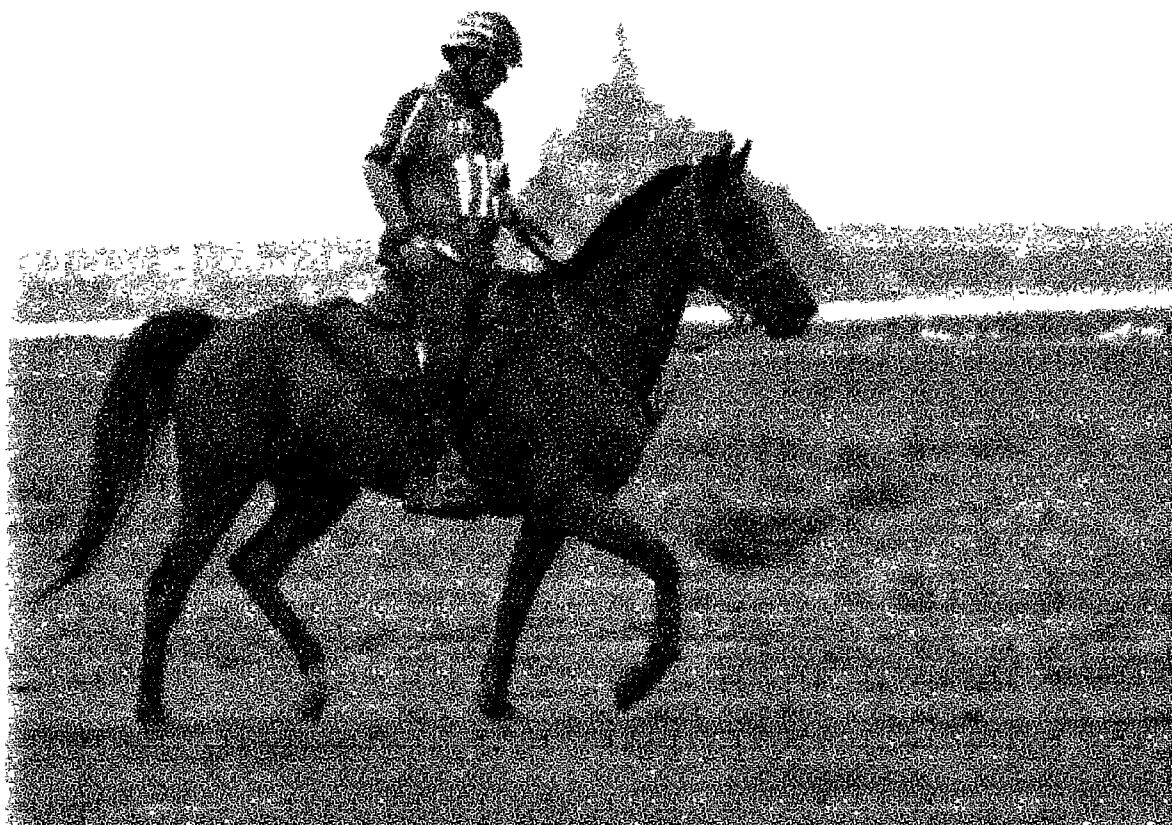


# Endurance
