In late 2011, PlanSmart NJ was awarded a three-year contract through the United States Department of Housing and Urban Development and facilitated through Rutgers, The State University of New Jersey. Work began in earnest on that project in 2012. The awarded contract, "North Jersey Sustainable Communities Consortium" name was changed to Together North Jersey. PlanSmart NJ is one of many partners involved in this project. PlanSmart NJ is the lead on the Society and Community Committee and is responsible for writing topic reports for Education, Health and Safety, and Arts and Culture. PlanSmart NJ was also responsible for conducting research and writing portions of the Fair Housing and Equity Assessment (FHEA) report. The topic reports and FHEA were used to help identify strategies and actions for the Together North Jersey final Plan that is scheduled to be released in 2015. In addition to the Together North Jersey Project, PlanSmart NJ held a series of policy briefings and a Regional Planning Summit.
