NJCASA adopted the provisions of Accounting Standards Codification ("ASC") 740, "Accounting for Uncertainty in Income Taxes". ASC 740 requires that a tax position be recognized or derecognized based on a "more likely than not" threshold. This applies to positions taken or expected to be taken in a tax return. The implementation of ASC 740 did not have an impact on NJCASA's statements of financial position or statements of activities. NJCASA does not believe its financial statements include any uncertain tax positions. NJCASA's Forms 990, Return of Organization Exempt from Income Tax, for the years ended December 31, 2013, 2012 and 2011 are subject to examination by the IRS, generally for three years after they are filed.
