INCORPORATED IN 1990, YOUTHBUILD USA HAS BEEN SINCE 1994 THE FEDERAL GOVERNMENT'S PRIMARY CONTRACTOR FOR TRAINING, TECHNICAL ASSISTANCE, AND QUALITY ASSURANCE FOR YOUTHBUILD GRANTEES, FIRST UNDER THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT, NOW UNDER THE U.S. DEPARTMENT OF LABOR. IN 2014, YOUTHBUILD USA PROVIDED TECHNICAL ASSISTANCE THROUGH SITE VISITS AND TELEPHONE CALLS TO DOL YOUTHBUILD GRANTEES, INCLUDING NEW DOL YOUTHBUILD GRANTEES. YOUTHBUILD USA CONDUCTED SEVERAL WEBINARS FOR DOL YOUTHBUILD GRANTEES, PROVIDED ONLINE REFERENCE MATERIALS, PARTICULARLY FOR GREEN BUILDING, AND HELP-DESK SERVICE FOR DATA MANAGEMENT SYSTEMS.
