THE YOUTH VILLAGE IS LOCATED ON 77 ACRES ATOP MOUNT CARMEL IN NORTHERN ISRAEL. THE YOUTH VILLAGE PROVIDES A HOME, A SAFE HAVEN, AND AN EDUCATION TO MORE THAN 400 AT-RISK IMMIGRANT CHILDREN FROM AROUND THE WORLD. THROUGH A DEEPLY SENSITIVE APPROACH TO LIVING AND LEARNING, AND A DEDICATED STAFF AND TEAM OF PROFESSIONALS, THESE FORMERLY TRAUMATIZED CHILDREN'S LIVES ARE TRANSFORMED. THEY DEVELOP SELF-ESTEEM AND LEADERSHIP SKILLS AND LEARN TO LIVE IN WHOLENESS. HEALTHY, CAPABLE, AND STRONG. THE YOUTH VILLAGE ALSO INCLUDES A HIGH SCHOOL, AN ART AND MUSIC CENTER, A MODERN COMPUTER CENTER, A CENTRAL DINING ROOM, LIBRARY, ECO-FARM, AND SPORTS FACILITIES. AFTER THE DECEMBER 2010 WILDFIRE IN THE YOUTH VILLAGE, REBUILDING BEGAN IMMEDIATELY WITH A MASSIVE CLEANUP, ELECTRIC AND COMMUNICATIONS WORK, THE REMOVAL OF DEBRIS AND DESTROYED BUILDINGS, AND MANY REPAIRS AND RENOVATIONS. BECAUSE OF THE EXTENSIVE DEVASTATION TO THE YOUTH VILLAGE, FYO RECOGNIZED THAT MAJOR REBUILDING WOULD BE NEEDED AND INITIATED A MASTER PLAN FOR THE YOUTH VILLAGE TAKING INTO ACCOUNT FUTURE NEEDS. CONSTRUCTION WAS STARTED IN OCTOBER 2012 AND A SIGNIFICANT PORTION OF THE PROJECT WAS COMPLETED BY DECEMBER 31, 2014, AND IS INCLUDED IN YEMIN ORDE YOUTH VILLAGE SUPPORT ON THE STATEMENTS OF ACTIVITIES. THE LAST PHASE, WHICH INCLUDES A NEW ROAD AND ENTRANCE AREA, WILL BE COMPLETED BY JUNE 30, 2015.
