TOBACCO CONTROL SUSTAINABILITY THE PERIOD HAS ALSO HIGHLIGHTED THE SIGNIFICANT IMPACT ON THE HEALTH AND WELL BEING OF COMMUNITIES THE PROGRAMME HAS ACHIEVED THE UNION HAS MADE MAJOR STRIDES FORWARD IN WERE IMPLEMENTED ACROSS INDIA WITH MIZORAM STATE, INCREASING VAT ON TOBACCO PRODUCTS FROM 13 5% TO 20% AND KERALA STATE RAISING TOBACCO TAXES BY 7 5% THE VAT AMENDMENT BILL IN MADHYA PRADESH SAW VAT ON TOBACCO PRODUCTS INCREASE FROM 13 TO 27 PERCENT WHILST IN HIMACHAL PRADESH, VAT ON CIGARETTES INCREASED TO 36% IN 2013 THE UNION'S WORK IN TOBACCO CONTROL LEGISLATION AND POLICY HAS DEMONSTRATED PROVEN HEALTH BENEFITS DURING THE HIGH LEVEL MINISTERIAL DELEGATION VISIT TO SCOTLAND, THE RUSSIAN MINISTER OF HEALTH PRESENTED THE LATEST FIGURES FROM THE RUSSIAN BUREAU OF STATISTICS WHICH SHOWED A 7% DECREASE IN SMOKING PREVALENCE SINCE THE PASSAGE OF THE NEW FEDERAL TOBACCO CONTROL LAW IN CHINA, THE IMPACT OF SMOKE-FREE POLICIES ON HEALTH IS INCREASINGLY EVIDENCE-DRIVEN WITH RESEARCH BY TIANJIN CDC REVEALING A SIGNIFICANT REDUCTION IN ACUTE MYOCARDIAL INFARCTION AMONG HOSPITAL PATIENTS WHO WORK IN INDOOR AREAS THE RESEARCH SHOWED THAT THE PERCENTAGE OF PATIENTS ADMITTED TO HOSPITAL
