The company provides life care to residents of Willow Valley Manor, a retirement facility that includes 295 residential units & a 60-bed healthcare facility, Willow Valley Lakes Manor, a retirement facility that includes 373 residential units, an 80-bed healthcare facility, 16 villa apartments, 36 midrise apartments, & 80 duplex & triplex residential units (the duplex & triplex units are collectively known as Willow Gables), Willow Valley Manor North, a retirement facility that includes 472 residential units and a 251-bed healthcare facility, and Spring Run at Willow Valley, a retirement facility that includes 210 residential units & a 138-bed healthcare facility. As an expansion of the Manor, the company has constructed 54 duplex and triplex units to be known as Providence Park at Willow Valley. Phase two of the expansion project consisting of 12 triplex units was completed in 2014.

Smartlife VIA Willow Valley is a membership based Lifecare at Home program delivering high quality care and services in the member's home. In addition, opportunities for social, educational and wellness activities are available. If needed, personal care, memory support and nursing care are available to the members.
