Reclaimed Hanover 9, which was formerly a strip mine site located near the City of Nanticoke in Luzerne County. The reclamation resulted in re-contouring the site, which resulted in remediating acid mine drainage. The completion of the project has provided a 300 acre site which is now available to be used for further economic, residential or ecological development. The project was funded primarily through grants.

4b (Code:) (Expenses \$ 531,784 including grants of \$) (Revenue \$)

Completed the installation of the maelstrom oxidizer which is designed to remediate acid mine drainage by removing iron oxide particles from the water. The oxidizer was installed at the Askam Borehole which discharges AMD into the Nanticoke Creek. This project has resulted in a reduction of the AMD which flows into the Nanticoke Creek. The majority of this project was funded through grants

Earth Conservancy operates a compost facility at its Newport Township site. The compost facility is available for the community and municipalities to dispose of yard waste. The yard waste is then recycled and turned into compost. The compost is then used for other reclamation projects or may be purchased by residents of the community.

(iii) consolidation or merger or (iv) the sale, lease, exchange, encumbrancing or other disposition of: (a) all or substantially all of the non-real estate property assets of the corporation; (b)any single non real estate asset with a value that exceeds \$500,000; (c) authorizing voluntary dissolution of the corporation; (d)adopting a plan for the distribution of the assets of the corporation.

Form 990 Part VI Section B Line 11b

A copy of the proposed 990 is presented to every member of the board during the first quarter board meeting. During the meeting, the return is discussed and recommendations for modifications are made. After all modification are made, the tax return is timely filed.

Form 990 Part VI Section B Line 12c

In addition to the distribution of the Conflict of Interest Policy, an annual written communication is distributing reiterating that a conflict of interest exists when an individual has a personal interest that may influence him or her when making a decision for the organization. Members of the Board are advised that the key is not to avoid all possible conflict of interest situations, but rather to identify and handle them effectively. Earth Conservancy believes that it is necessary to identify potential conflicts of interest on a timely basis. For this reason, the organization periodically requires that a written Declaration of Affiliation is completed and returned for review by members of the Board of Directors and management as necessary. Additionally, a written summation of family or business relationships among officers, directors or key employees is obtained.

The Executive Committee of the Board of Directors is responsible for determining the annual compensation for the Chief Executive Officer and Key Employees, as defined in the instructions in the

appendix to Form 990 The committee provides written documentation that it has considered (1) whether adequate capital has been acquired to enable significant accomplishments, consistent with the mission of Earth Conservancy; (2) whether there is a demonstrated willingness to take reasonable risks to meet mission objectives; (3) whether operating accomplishments have been satisfactory; (4) whether communication and involvement with the Board and its committees have been timely and purposeful; and that (5) the compensation is reasonable based upon the level of experience and performance of the individual in relationship to other individuals with comparable responsibilities.
